SENATE CONCURRENT RESOLUTION

REQUESTING THE HAWAII TEACHER STANDARDS BOARD TO ACCEPT THE
NATIONAL ORIENTATION AND MOBILITY CERTIFICATION FOR
TEACHERS PROVIDING ORIENTATION AND MOBILITY SERVICES.

1 WHEREAS, the Department of Education has perennially
2 struggled to fill vacancies for teacher of blind students or
3 teacher of the visually impaired positions, including positions
4 providing specialized instruction in orientation and mobility;
5 and
6

7 WHEREAS, blind children in Hawaii end up being underserved
8 with regard to orientation and mobility in the Department of
9 Education, reducing their opportunity to participate equally and
10 meaningfully with their sighted peers and build their capacity
11 to contribute to the State's communities; and
12

13 WHEREAS, the Department of Education currently has no
14 employees who hold the National Orientation and Mobility
15 Certification (NOMC) from the National Blindness Professional
16 Certification Board (NBPCB); and

18 WHEREAS, for the teaching of orientation and mobility, the
19 Department of Education currently only accepts the Certified
20 Orientation and Mobility Specialist certification from the
21 Academy for Certification of Vision Rehabilitation and Education
22 Professionals, which only gives the Department of Education the
23 personnel resources to provide vision-centered orientation and
24 mobility services, one of two major forms of orientation and
25 mobility; and

27 WHEREAS, the Hawaii Teacher Standards Board currently does
28 not accept the NOMC offered by the NBPCB, making the Department
29 of Education unable to provide Structured Discovery Cane Travel,
30 a service which can only be provided by a professional certified
31 by the NBPCB; and

1 WHEREAS, when parents of blind children needing Structured
2 Discovery Cane Travel request it as a service on their
3 Individualized Education Plans, they are consistently told that
4 the Department of Education is unable to provide this service,
5 thus leaving their blind child without sufficient services; and

7 WHEREAS, for decades, Structured Discovery Cane Travel has
8 been empowering blind children and adults across the United
9 States, helping them build confidence and feelings of self-
10 respect as they navigate their world safely and without shame
11 about their blindness; and
12

13 WHEREAS, the methods and principles that undergird
14 Structured Discovery Cane Travel come from the lived experiences
15 of blind men and women who have shared their experiences,
16 attitudes, and techniques with each other since 1940, leading to
17 instructional services consisting of non-visual techniques,
18 problem solving strategies, experiential learning, confidence
19 building experiences, and the role modeling of non-visual
20 techniques, which demonstrate their effectiveness while
21 correcting misconceptions about blindness; and

23 WHEREAS, the NOMC from the NBPCB is already accepted by the
24 Hawaii Division of Vocational Rehabilitation in order to provide
25 orientation and mobility services, where, in fact, all current
26 providers of orientation and mobility services are blind adults
27 certified by the NBPCB; now, therefore,
28

29 BE IT RESOLVED by the Senate of the Thirtieth Legislature
30 of the State of Hawaii, Regular Session of 2020, the House of
31 Representatives concurring, that the Hawaii Teachers Standards
32 Board is requested to accept the National Orientation and
33 Mobility Certification from the National Blindness Professional
34 Certification Board for teachers providing orientation and
35 mobility services in the Department of Education; and

37 BE IT FURTHER RESOLVED that certified copies of this
38 Concurrent Resolution be transmitted to the Governor, Lieutenant
39 Governor, Chairperson of the Board of Education, Superintendent
40 of the Department of Education, Chair of the Hawaii Teacher
41 Standards Board, Administrator of the Hawaii Division of
42 Vocational Rehabilitation Services for the Blind Branch
