## SENATE CONCURRENT RESOLUTION

REQUESTING THE GOVERNOR TO RECOGNIZE AND COMMEMORATE AUGUST 26, 2020, AS WOMEN'S EQUALITY DAY, CELEBRATING THE CENTENNIAL OF, AND HONORING HAWAII'S ROLE IN, THE WOMEN'S SUFFRAGE MOVEMENT.

1           WHEREAS, in a landmark constitutional victory, the  
2 Nineteenth Amendment enshrined in the United States Constitution  
3 a more expansive democracy for the nation on August 26, 1920, by  
4 prohibiting states from denying the right to vote on the basis  
5 of sex; and  
6

7           WHEREAS, Jeannette Rankin, appointed to the Committee on  
8 Woman Suffrage in the Sixty-Fifth session of Congress was the  
9 first female member elected and sworn into Congress in April of  
10 1917, one of numerous influential females on the front lines of  
11 the fight for national suffrage; and  
12

13           WHEREAS, women suffragists such as Elizabeth Cady Stanton,  
14 Lucretia Mott, and Susan B. Anthony first organized and  
15 collectively fought for women's suffrage rights at the national  
16 level in July of 1848; and  
17

18           WHEREAS, during his reign, King Kalākaua also recognized  
19 the importance of including women in political decision-making,  
20 he relied on the service and advice of women like Emma  
21 Ka'ilikapuolono Metcalf Beckley Nakuina, who was appointed  
22 Commissioner of Private Ways and Water Rights from 1892 to 1907;  
23 and  
24

25           WHEREAS, Emma Ka'ilikapuolono Metcalf Beckley Nakuina hosted  
26 social gatherings of nationally acclaimed women's suffragists;  
27 and  
28

29           WHEREAS, Wilhelmina Kekelaokalaninui Widemann Dowsett, a  
30 native Hawaiian, founded the National Women's Equal Suffrage



1 Association in 1912, and hosted meetings in her home in an  
2 active fight for suffrage encouraging Hawaiian women with her  
3 passion for the movement; and  
4

5 WHEREAS, Queen Lili'uokalani, sister to King Kalākaua, as  
6 the first and only Queen of Hawaii was a powerful symbol of a  
7 woman's ability to govern and participate in civic life; and  
8

9 WHEREAS, the constitutional monarchy of Hawaii was  
10 overthrown in 1893, and in 1898, Hawaii became a United States  
11 territory; and  
12

13 WHEREAS, native Hawaiians argued that as a territory they  
14 should have suffrage rights in the United States; and  
15

16 WHEREAS, although, in 1920 Hawaii was not a state and  
17 therefore could not vote on the Nineteenth Amendment, Hawaiian  
18 women became enfranchised along with their mainland sisters; and  
19

20 WHEREAS, as a celebratory symbol in support of the passage  
21 of the Nineteenth Amendment, the people of Hawaii sent a  
22 ratification star, which is currently displayed at Belmont-Paul  
23 Women's Equality National Monument in Washington, to the  
24 National Woman's Party; and  
25

26 WHEREAS, the State has been memorialized by the exemplary  
27 leadership of numerous influential women in service of the  
28 United States as members of Congress; and  
29

30 WHEREAS, Mary Elizabeth Farrington, publisher of the  
31 "Honolulu Star-Bulletin", served the Eighty-Third and Eighty-  
32 Fourth Congressional Sessions; and  
33

34 WHEREAS, Patsy Takemoto Mink, was born in Paia, was the  
35 first woman of color elected to Congress, and was elected and  
36 sworn into the Eighty-Ninth, Ninety-First, Ninety-Third, One  
37 Hundred-First, and One Hundred-Fifth Sessions. Her contributions  
38 to Hawaii have been commemorated by the State's dedication of a  
39 statue honoring her legacy; and

1 WHEREAS, Patricia Saiki worked to preserve Hawaii's natural  
2 beauty and unique resources as a member of the One Hundredth  
3 Congress; and

4  
5 WHEREAS, Mazie Hirono, a graduate of Kaimuki High School  
6 and the University of Hawaii, served seven consecutive sessions  
7 beginning with the One Hundred-Tenth Congressional Session; and

8  
9 WHEREAS, Colleen Hanabusa, who grew up in Waianae, Oahu,  
10 served three terms in the United States House of  
11 Representatives, beginning in 2011; and

12  
13 WHEREAS, Tulsi Gabbard has represented the State in  
14 Congress since 2012; and

15  
16 WHEREAS, the daughters, granddaughters, and great-  
17 granddaughters of the women, who fought so hard to vote, have  
18 been making their voices heard at the polls for nearly one  
19 hundred years; and

20  
21 WHEREAS, most of the women, who began asking for the right  
22 to vote, never lived to see the enfranchisement of women; and

23  
24 WHEREAS, women are currently running for office in  
25 unprecedented numbers. Many current politicians, both male and  
26 female, remember that they follow in the footsteps of these  
27 great suffragists; and

28  
29 WHEREAS, Congress passed a joint resolution in 1973,  
30 declaring August twenty-sixth as National Women's Equality Day,  
31 to commemorate the certification of the Nineteenth Amendment to  
32 the United States Constitution; now, therefore,

34 BE IT RESOLVED by the Senate of the Thirtieth Legislature  
35 of the State of Hawaii, Regular Session of 2020, the House of  
36 Representatives concurring, that this body requests the Governor  
37 to recognize and commemorate August 26, 2020, as Women's  
38 Equality Day, celebrating the centennial of, and honoring  
39 Hawaii's role in, the Women's Suffrage Movement, thus  
40 reaffirming its commitment to empowering and uplifting the  
41 voices of women across our great State; and

1 BE IT FURTHER RESOLVED that certified copies of this  
2 Concurrent Resolution be transmitted to the Governor, Senate  
3 President, Speaker of the House of Representatives, League of  
4 Women Voters of Hawaii, and Patsy Mink Foundation.
