**University of Hawai'i Cost Impacts of Providing Workers' Compensation Coverage
for Students
Pursuant to HRS § 302A-431**

Section 302A-431, Hawai'i Revised Statutes (HRS), requires the University of Hawai'i – along with the Department of Education – to submit a biennial report to the governor and the legislature prior to the convening of each regular session in the first year of each biennium that identifies the cost impacts to the State of providing workers' compensation coverage for students under sections 302A-430 and 302A-440, HRS.

Below is a list of claims to the University of Hawai'i for workers' compensation coverage and cost impacts to the state since 2015.

Fiscal Biennium	Provided Workers' Comp Coverage	Cost Impacts
2014-2016	One (1) claim	\$1,046.36 ¹
2016-2018	No claims	\$0
2018-2020	One (1) "Records Only" claim ²	\$0

¹ \$262.72 paid in FY 2016 + \$783.64 paid in FY 2017; claim closed in FY 2017.

² One claim was reported to the insurance carrier, but there were \$0 cost impacts and 0 lost work hours
