(a) In FY21, the State of Hawaii did not release the General Fund appropriation as conditioned in Act 37, pending the completion of an audit by the state auditor, of which the state auditor suspended work in December 2019.

**NOTES and ASSUMPTIONS**

1. General Fund appropriations drawn from the State of Hawaii per 2019 Act 037 HB172.
2. Public Land Trust revenues per Act 178, SLH 2006 is stated as an Interim amount of \$15,100,000 per year.
3. Charges for Services FY21 revenue based on OHA approved fiscal biennium 2020 and 2021 budget realignment #2, FY22 at 10% decrease due to COVID-19 market impact, no increase in FY23 as the economy recovers from COVID-19, and estimated at a 2% increase thereafter using FY23 projection.
4. Dividend & Interest Revenues include realized gains/losses on investments. Due to restrictions placed on investment income and numerous variables impacting forecast accuracy, estimates for FY20 - FY21 are at 5% of 20-quarter average market value. Estimates no increase in FY22 due to COVID-19 financial market impact, and FY23 - FY27 are calculated at a 2% increase using FY 22 projection.
5. Federal and Other Grants revenues are based on anticipated expenditures as payments are on reimbursement basis.
6. Revenue derived from OHA newspaper ads.
7. Donations, unused grant refunds, and other income fluctuate between years and are therefore not being considered for purposes of this analysis.
8. Kakaako Makai reserve for Legacy Property management funding.
9. Fiscal Stabilization Fund: (for budget stabilization and emergencies)
  - ... \$3,000,000 for budget stabilization purposes in replacing the FY21 General Funds appropriation, as conditioned in (2019) Act 37, refer to footnote (a).
  - ...\$1,000,000 for FY21 COVID-19 contingencies: \$500,000 for OHA operations to address operational needs, \$500,000 for beneficiary grants to provide additional beneficiary supports as a result of COVID-19 impacts.
- 10-12. Expenditures estimates for FY 21 to FY 27 based on OHA's approved fiscal biennium 2020 and 2021 budget realignment #2.
  - ...Increase \$630K in FY21 in personnel fringe as an impact of State of Hawaii not releasing \$1MM for General Fund personnel funding.
  - ...Estimate no increase in FY22 expenditures due to COVID 19 impact (see note 3 & note 4), and FY23 - FY27 calculated at a conservative 1% increase using FY22 projection given uncertainties to COVID-19.
