A BILL FOR AN ACT

RELATING TO TELEHEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the novel
- 2 coronavirus disease 2019 (COVID-19) pandemic has substantially
- 3 impacted the way patients access health care by increasing the
- 4 demand for and use of telehealth to diagnose, treat, and monitor
- 5 illness.

- 6 In Act 20, Session Laws of Hawaii 2009, the legislature
- 7 noted that, since 1999, it "has supported the use and expansion
- 8 of telehealth services and technology in Hawaii" as a way to
- 9 increase access and reduce delays to health care, particularly
- 10 in rural areas of the State.
- 11 The legislature further finds that the COVID-19 pandemic
- 12 has resulted in an increased use of telehealth services.
- 13 However, the existing state law relating to the practice of
- 14 telehealth is ambiguous regarding whether a patient can use
- 15 telehealth to establish a relationship with a physician. This
- 16 could result in delayed access to care in many instances where
