A BILL FOR AN ACT

RELATING TO PUBLIC SCHOOL LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The attorney general of the State, on behalf of
2 the department of education, shall institute proceedings to
3 acquire by voluntary action or by condemnation with existing
4 improvements thereon pursuant to chapter 101, Hawaii Revised
5 Statutes:

6 (1) The portion of the parcel of land owned by the
7 Mililani Town Association identified as lot 2755-C on
8 land court map 325, which constitutes a portion of tax
9 map key 9-5-001:83; and

10 (2) The portion of the parcel of land owned by the
11 Mililani Town Association that fronts Mililani high
12 school and is identified as lot 5392-B on the city and
13 county of Honolulu department of planning and
14 permitting subdivision approval dated November 22,
15 2019, which constitutes a portion of tax map
16 key 9-5-001:017.

17 SECTION 2. The attorney general, on behalf of the
18 department of education, shall acquire or take the property



1 described in section 1 of this Act in its existing condition,
2 and shall provide for the indemnification of the Mililani Town
3 Association for all claims and liabilities against the Mililani
4 Town Association that may arise concerning the physical,
5 environmental, soil, economic, and legal conditions of the
6 property, from the effective date of this Act until the
7 voluntary action or the condemnation process is complete.

8 SECTION 3. This Act shall take effect upon its approval.
