Dear Senate President Kouchi and Speaker Saiki:

The Hawai'i Government Employees Association (HGEA) and the employer have reached an agreement concerning collective bargaining (CB) for Units 2, 3, 8, and 13. Notification of ratification of the CB agreement was issued on April 22, 2021. The only cost items are for Employer-Union Trust Fund (EUTF) contributions. In accordance with Section 89-10(b), cost items must be submitted to the Legislature for appropriation. In addition, executive orders are being drafted to extend the same terms to not only the excluded counterparts for Units 2, 3, 8, and 13, but also for the excluded counterparts of Units 4, 5, 6, 9, 11, and 14.

The following summary of the included and excluded requirements of the settlement for the current fiscal biennium are being transmitted to the Legislature for authorization:
