### A BILL FOR AN ACT

RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 329-104, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows: 2 3 This section shall not prevent the disclosure, at the 4 discretion of the administrator, of investigative information 5 to: (1) Law enforcement officers, investigative agents of 6 federal, state, or county law enforcement or 7 regulatory agencies, United States attorneys, county 9 prosecuting attorneys, or the attorney general; 10 provided that the administrator has reasonable grounds to believe that the disclosure of any information 11 12 collected under this part is in furtherance of an 13 ongoing criminal or regulatory investigation or 14 prosecution; 15 (2) Registrants authorized under chapters 448, 453, and 463E and section 457-2.7 who are registered to 16 17 administer, prescribe, or dispense controlled

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM.

PURPOSE:

To amend section 329-104, Hawaii Revised Statutes (HRS), to: (1) clarify that an advanced practice registered nurse or pharmacist may access information stored in the electronic prescription accountability system (EPAS); (2) allow authorized employees of the State of Hawaii Department of Human Services, Med-QUEST division to access EPAS information; and (3) allow controlled substances prescribers, dispensers, and pharmacists employed by United States Department of Veterans Affairs facilities in Hawaii, who submit data of dispensing activity as described in section 329-101, HRS, to access prescription information stored in the EPAS.

MEANS:

Amend section 329-104(c), HRS.

JUSTIFICATION:

Proposed amendments to chapter 329 will accomplish the following:

- (1) Clarify that an advanced practice registered nurse may access prescription information stored in the electronic prescription accountability system;
- (2) Clarify that a pharmacist may access information stored in the electronic prescription accountability system to review prescription information about a customer; and
- (3) Allow authorized employees of the State of Hawaii Department of Human Services, Med-QUEST Division, as well as, controlled substances prescribers, dispensers, and pharmacists employed by

United States Department of Veterans Affairs facilities in Hawaii, who submit data of dispensing activity as described in chapter 329-101, to access prescription information stored in the electronic prescription accountability system.

Impact on the public: This bill is intended to aid advanced practice registered nurses, pharmacists, Med-QUEST staff, and controlled substances prescribers, dispensers, and pharmacists employed by United States Department of Veterans Affairs facilities in Hawaii in accessing up-to-date and accurate prescription information stored in the electronic prescription accountability system to better serve their patients and clients.

Impact on the department and other agencies:
These proposed amendments would assist the
Department's Narcotics Enforcement Division by
clarifying who may access prescription
information stored in the electronic
prescription accountability system and assist
advanced practice registered nurses and
pharmacists, the Department of Human Services
Med-QUEST Division, and the U.S. Department of
Veterans Affairs in aiding their patients and
clients.
