
A BILL FOR AN ACT

RELATING TO VACANCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 17-1, Hawaii Revised Statutes, is
2 amended by amending its title and subsection (a) to read as
3 follows:

4 "~~§17-1 [United States senator.]~~ Congressional and
5 legislative offices. (a) Except as provided in subsection (b),
6 when a vacancy occurs in the ~~[office]:~~

7 (1) Office of United States senator~~[r];~~

8 (2) Representation of this State in the United States
9 House of Representatives;

10 (3) Membership of the state senate; or

11 (4) Membership of the state house of representatives,

12 the ~~[vacancy shall be filled for the unexpired term at the~~
13 ~~following state general election; provided that the vacancy~~
14 ~~occurs not later than 4:30 p.m. on the twenty-first day prior to~~
15 ~~the date specified in section 12-6 for the close of filing~~
16 ~~nomination papers for regularly scheduled elections; otherwise~~
17 ~~at the state general election next following. The] chief~~



1 election officer shall issue a proclamation [~~designating the~~
2 for an election [~~for filling~~] to fill the vacancy. [~~All~~
3 ~~candidates for the unexpired term shall file nomination papers~~
4 ~~not later than the date and time specified in section 12-6 and~~
5 ~~shall be nominated and elected in accordance with this title.~~
6 ~~Pending the election, the governor shall make a temporary~~
7 ~~appointment to fill the vacancy by selecting a person from a~~
8 ~~list of three prospective appointees submitted by the same~~

2 filed, the time for transmitting to county clerks the notice
3 designating the offices for which candidates are to be elected,
4 the time for transmitting to county clerks lists of candidates
5 to be voted for at the special election, and any other matters
6 as provided for in section 11-91 that are not inconsistent with
7 this section. The special election shall be conducted and the
8 results ascertained so far as practicable, in accordance with
9 this title."

10 SECTION 2. Section 17-2, Hawaii Revised Statutes, is
11 repealed.

12 [~~"§17-2 United States representative. When a vacancy~~
13 ~~occurs in the representation of this State in the United States~~
14 ~~House of Representatives, the chief election officer shall issue~~
15 ~~a proclamation for an election to fill the vacancy. The~~
16 ~~proclamation shall be issued not later than on the sixtieth day~~
17 ~~prior to the election to fill the vacancy and shall contain the~~
18 ~~date, time, and places where the special election is to be held,~~
19 ~~the time within which nomination papers shall be filed, the time~~
20 ~~for transmitting to county clerks the notice designating the~~

11 ~~the next succeeding general election:~~

12 (1) ~~The governor shall make an appointment within sixty~~
13 ~~calendar days following the first day of vacancy to~~
14 ~~fill the vacancy for the unexpired term by selecting a~~
15 ~~person from a list of three prospective appointees~~
16 ~~submitted by the same political party as the prior~~
17 ~~incumbent. The appointee shall be at the time of~~
18 ~~appointment, and for at least six months immediately~~
19 ~~prior to the appointment, a member of the political~~
20 ~~party. The appointee shall, at the time of~~
21 ~~appointment, be a resident of the same senate district~~



1 ~~as the prior incumbent. The political party shall~~
2 ~~submit the list of prospective appointees to the~~

7 ~~the governor shall make an appointment within sixty calendar~~
8 ~~days following the first day of vacancy to fill the vacancy for~~
9 ~~the unexpired term by selecting a person from a list of three~~
10 ~~prospective appointees submitted by the same political party as~~
11 ~~the prior incumbent. The appointee shall be, at the time of~~
12 ~~appointment, and shall have been, for at least six months~~
13 ~~immediately prior to the appointment, a member of the political~~
14 ~~party. The appointee shall, at the time of appointment, be a~~
15 ~~resident of the same state representative district as the prior~~
16 ~~incumbent. The political party shall submit the list of~~
17 ~~prospective appointees to the governor within thirty calendar~~
18 ~~days following the first day of vacancy.~~


5 SECTION 5. This Act does not affect rights and duties that
