

A BILL FOR AN ACT

RELATING TO CESSPOOL CONVERSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 342D-72, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+] §342D-72[+] Cesspools; mandatory upgrade, conversion, 4 or connection. (a) Prior to January 1, 2050, every cesspool in 5 the State, excluding cesspools granted exemptions by the 6 director of health pursuant to subsection (b), shall be: 7 (1) Upgraded or converted to [a septic system or aerobic 8 treatment unit system;] a department-approved 9 wastewater system; or 10 (2) Connected to a sewerage system. 11 (b) The director of health may grant exemptions from the 12 requirements of subsection (a) to property owners of cesspools 13 that apply for an exemption and present documentation showing a legitimate reason that makes it infeasible to upgrade, convert, 14 15 or connect the cesspools. For the purposes of this subsection, 16 a legitimate reason shall include but not be limited to: 17 (1) Small lot size;
