

A BILL FOR AN ACT

RELATING TO SAFE WATER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the practice of
- 2 adding fluoridation chemicals to public drinking water is
- 3 dangerous for many of the State's residents. The National
- 4 Toxicology Program recently concluded that fluoride is a
- 5 "presumed" neurotoxin. The National Research Council called
- 6 fluoride an endocrine disruptor, and studies show that it lowers
- 7 thyroid function, particularly in women. Fluoride has been
- 8 linked to sleep apnea and kidney and liver impairment in
- 9 adolescents. A large body of government-funded research has
- 10 also associated fluoride neurotoxicity with lower IQs in
- 11 children and with attention deficit hyperactivity disorder and
- 12 related behaviors.
- 13 The legislature finds that bottle-fed infants are exposed
- 14 to the highest doses of fluoride when fluoridated water is used
- 15 to mix their formula. Studies show that up to fifty-nine per
- 16 cent of formula-fed babies exceed the upper safe limit set by
- 17 the Institute of Medicine.

- 1 The legislature further finds that fluoridated water has
- 2 largely been rejected as a preventative dental strategy. The
- 3 Centers for Disease Control and Prevention have found that the
- 4 primary dental benefits of fluoride are as a topical treatment.
- 5 Accordingly, the purpose of this Act is to ensure safer
- 6 water in the State by prohibiting all suppliers of public water
- 7 from adding fluoridation chemicals.
- 8 SECTION 2. Section 340E-7, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- 10 "\$340E-7 Prohibited acts. (a) No supplier of water shall
- 11 violate any rule adopted pursuant to section 340E-2.
- 12 (b) No supplier of water shall violate any condition or
- 13 provision of a variance, exemption, permit, or other written
- 14 authorization issued under this part.
- 15 (c) No supplier of water shall violate any requirement of
- 16 an emergency plan promulgated pursuant to section 340E-5.
- (d) No supplier of water shall violate any rule adopted
- 18 under section 340E-6 or disseminate any false or misleading
- 19 information with respect to notices required pursuant to
- 20 section 340E-6 or with respect to remedial actions undertaken to

- 1 achieve compliance with state primary drinking water
- 2 regulations.
- 3 (e) No person shall violate any order issued by the
- 4 director pursuant to this part.
- 5 (f) No person shall cause a public water system to violate
- 6 the state primary drinking water regulations.
- 7 (q) No person shall violate underground injection control
- 8 rules adopted pursuant to this part.
- 9 (h) No person shall fail or refuse to comply with the
- 10 director's authority to inspect the premises of a supplier of
- 11 water pursuant to section 340E-4.6.
- (i) No person shall install or repair any public water
- 13 system or any plumbing in a residential or nonresidential
- 14 facility providing water for human consumption which is
- 15 connected to a public water system with any pipe, solder, flux,
- 16 plumbing fittings, or fixtures that are not lead free. "Lead
- 17 free" with respect to solders and flux means containing not more
- 18 than 0.2 per cent lead, with respect to pipes and pipe fittings
- 19 means containing not more than 8.0 per cent lead and with
- 20 respect to plumbing fittings and fixtures means those in
- 21 compliance with National Sanitation Foundation Standard 61,

- 1 section 9. This subsection shall not apply to leaded joints
- 2 necessary for the repair of cast iron pipes.
- 3 (j) No person shall violate rules on public water system
- 4 capacity adopted pursuant to this part.
- 5 (k) No person or supplier of water shall introduce
- 6 fluoride to a public water system. Any statutes, executive
- 7 orders, ordinances, regulations, or rules that regulate the use
- 8 of fluoride in the State's public water systems are preempted
- 9 and existing statutes, executive orders, ordinances,
- 10 regulations, or rules conflicting with this subsection are
- 11 void."
- 12 SECTION 3. New statutory material is underscored.
- 13 SECTION 4. This Act shall take effect upon its appgroval.
