
A BILL FOR AN ACT

RELATING TO STATE FINANCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. Chapter 37, Hawaii Revised Statutes, is amended
3 by adding two new sections to be appropriately designated and to
4 read as follows:

5 "§37- Non-general fund program measures reports. No
6 later than November 1 annually, each department shall submit to
7 the legislature a report for each non-general fund account that
8 shall include but not be limited to the following:

- 9 (1) A statement of its objectives;
10 (2) Measures quantifying the target population to be
11 served for each of the ensuing six fiscal years;
12 (3) Measures by which the effectiveness in attaining the
13 objectives is to be assessed;
14 (4) The level of effectiveness planned for each of the
15 ensuing six fiscal years;
16 (5) A brief description of the activities encompassed;
17 (6) The program size indicators; and



1 (7) The program size planned for each of the next six
2 fiscal years.

3 **§37- Non-general fund cost element reports.** No later
4 than November 1 annually, each department shall submit to the
5 legislature a report for each non-general fund that shall
6 include but not be limited to the following:

- 7 (1) Budget details by cost element; and
- 8 (2) Non-general fund names and account codes for each item
9 or object code."

10 SECTION 2. Section 37-47, Hawaii Revised Statutes, is
11 amended to read as follows:

- 13 required for the purposes of bond conveyance or other
- 14 related bond obligations;
- 15 (10) The amount of moneys in the account derived from bond
- 16 proceeds; and
- 17 (11) The amount of moneys of the fund held in certificates
- 18 of deposit, escrow accounts or other investments."

16 (B) Thereafter, 1.125 cents per cigarette, but not
17 more than \$7,400,000 in a fiscal year, shall be

2 more than \$8,800,000 in a fiscal year, shall be

7 but not more than \$8,800,000 in a fiscal year,
8 shall be deposited to the credit of the emergency

11 (b) The department shall provide an annual accounting of
12 these dispositions to the legislature."

13 PART III

14 SECTION 6. The University of Hawaii cancer center (UH
15 cancer center) reduces the burden of cancer through research,
16 education, patient care, and community outreach. The UH cancer
17 center is the only National Cancer Institute (NCI)-designated
18 cancer center in Hawaii and the Pacific region. The UH cancer
19 center is a member of the Hawaii Cancer Consortium along with
20 five hospital groups and the University of Hawaii John A. Burns
21 school of medicine (JABSOM).



1 JABSOM educates and trains health care professionals,
2 including physicians, biomedical scientists, and allied health
3 workers. JABSOM also conducts fundamental medical research and
4 translates discoveries into delivery practices. Because JABSOM
5 is a community-based medical school without its own university
6 hospital, it partners with private hospitals in the community to
7 achieve its educational mission.

8 The public funds and other resources the State has made
9 available to JABSOM and the UH cancer center have been
10 substantial. The magnitude of state funds and other resources
11 provided to the University of Hawaii, the distinction of the
12 university being the sole public institution of higher education
13 in the State, and the UH cancer center being the only NCI-
14 designated cancer center in Hawaii underscore the importance of
15 establishing complementary strategic priorities and coordinating
16 the management and deployment of state resources appropriated to
17 JABSOM and UH cancer center.

18 It is in the public's interest that State resources be
19 efficiently and effectively managed to optimize the public
20 benefits. Just as co-locating the physical facilities for
21 JABSOM and UH cancer center on adjoining sites in Kakaako



1 promotes synergistic efforts, the legislature determines that it
2 is a statewide concern to ensure that the management of public
3 resources provided to JABSOM and UH cancer center be integrated,
4 coordinated, and focused on common priorities to avoid
5 unnecessary duplication of administrative expenses or
6 conflicting priorities.

7 Placing resources devoted to training and educating
8 physicians and conducting cancer research in an integrated
9 university organizational structure as opposed to stand-alone
10 and duplicative organizations will foster a uniform strategic
11 vision. Unified leadership will also allow better coordination
12 with the University of Hawaii's private partners in the hospital
13 community and with other state agencies.

14 The legislature finds that as a matter of statewide
15 concern, the UH cancer center should be more closely affiliated
16 with JABSOM and be administered as an organized research unit of
17 JABSOM. Merging JABSOM and the UH cancer center's
18 administrative services and infrastructure teams will offer
19 efficiency by eliminating redundancy and sharing administrative
20 expertise and experience to reduce processing delays.



1 The legislature notes that several outstanding medical
2 schools at other universities integrate their cancer research
3 programs closely with their medical schools. For example, the
4 Washington University School of Medicine in St. Louis is the
5 parent institution to the Siteman Cancer Center. The Siteman
6 Cancer Center is designated as a comprehensive cancer center and
7 holds an "exceptional" rating from the NCI. The MD Anderson
8 Cancer Center in Houston, Texas is a comprehensive cancer center
9 and operates in close affiliation with the McGovern Medical
10 School as part of the University of Texas Health Science Center
11 at Houston.

12 The legislature also notes that from 2014 to 2016, the
13 University of Hawaii developed business plans, hired
14 consultants, and made presentations to its board of regents on
15 the university's plans to integrate the University of Hawaii
16 Kakaako health science campus and eliminate operational
17 redundancies between JABSOM and the UH cancer center. Further,
18 the University of Hawaii frequently groups different organized
19 research units within a larger administrative structure. For
20 example, the school of ocean and earth science and technology
21 encompasses several outstanding research units, including the



1 center for microbial oceanography: research and education and
2 Hawaii institute of marine biology.

3 To maintain the NCI designation as a cancer center
4 consistent with NCI guidelines, the director of the UH cancer
5 center shall continue to have a direct line of reporting and
6 accountability to the provost of the University of Hawaii at
7 Manoa.

8 Accordingly, the purpose of this part is to require:

- 9 (1) The director of UH cancer center to be appointed by
10 the University of Hawaii's board of regents upon
11 recommendation from the provost of the University of
12 Hawaii at Manoa instead of the dean of JABSOM;
- 13 (2) The UH cancer center to be administratively affiliated
14 with JABSOM;
- 15 (3) The director of the UH cancer center to report to the
16 provost of the University of Hawaii at Manoa and
17 coordinate with the president of the university;
- 18 (4) Funds expended from or originating from the University
19 of Hawaii tuition and fees special fund established by
20 section 304A-2153, Hawaii Revised Statutes, for JABSOM



1 or the UH cancer center to be used for educational
2 purposes only; and

3 (5) Funds expended from or originating from the research
4 and training revolving fund established by section
5 304A-2253, Hawaii Revised Statutes, for JABSOM or the
6 UH cancer center to be used for research and research-
7 related purposes only.

8 SECTION 7. Chapter 304A, part IV, Hawaii Revised Statutes,
9 is amended by adding a new subpart to be appropriately
10 designated and to read as follows:

11 " . **Cancer Research Center of Hawaii**

12 **§304A- Cancer research center of Hawaii.** (a) There is
13 established an organized research unit, hereinafter known as the
14 "cancer research center of Hawaii", to conduct cancer research.
15 The cancer research center of Hawaii shall be administered by a
16 director to be appointed by the board of regents upon
17 recommendation by the provost of the University of Hawaii at
18 Manoa with the concurrence of the president of the university.
19 The cancer research center of Hawaii shall be affiliated with
20 the John A. Burns school of medicine; provided that the director
21 of the cancer research center of Hawaii shall report to the



1 provost of the University of Hawaii at Manoa and coordinate with
2 the president of the university.

3 (b) Notwithstanding any other law to the contrary, funds
4 expended from or originating from the University of Hawaii
5 tuition and fees special fund, established under section
6 304A-2153, for the school of medicine or the cancer research
7 center of Hawaii shall be used by the school of medicine or the
8 cancer research center of Hawaii for educational purposes only.

9 (c) Notwithstanding any other law to the contrary, funds
10 expended from or originating from the research and training
11 revolving fund, established under section 304A-2253, for the
12 school of medicine or the cancer research center of Hawaii shall
13 be used by the school of medicine or the cancer research center
14 of Hawaii for research and research-related purposes only.

15 (d) The cancer research center of Hawaii's research agenda
16 shall focus on research, education, patient care, and community
17 outreach and should reflect an understanding of the ethnic,
18 cultural, and environmental characteristics of the State and the
19 Pacific region. The cancer research center of Hawaii may:

- 20 (1) Engage in international research collaborations;
- 21 (2) Undertake research studies and clinical trials; and



1 (3) Participate in projects and programs of the National
2 Cancer Institute."

3 SECTION 8. Section 304A-2153, Hawaii Revised Statutes, is
4 amended to read as follows:

5 "**§304A-2153 University of Hawaii tuition and fees special**

6 **fund.** (a) There is established the University of Hawaii
7 tuition and fees special fund into which shall be deposited all
8 revenue collected by the university for regular, summer, and
9 continuing education credit tuition, tuition-related course and
10 fee charges, and any other charges to students, except as
11 provided by law. Moneys deposited into the fund shall be
12 expended to maintain or improve the university's programs and
13 operations and shall not be:

14 (1) Used as a justification for reducing any budget
15 request or allotment to the university unless the
16 university requests such a reduction;

17 (2) Transferred unless otherwise authorized by the
18 legislature; and

19 (3) Restricted by the governor or the director of finance
20 without the prior approval of the legislature.



1 Any rule, policy, or action of any agency or individual in
2 contravention of this subsection shall be void as against public
3 policy.

4 (b) Any law to the contrary notwithstanding, the board of
5 regents may authorize expenditures of up to \$3,000,000 annually,
6 excluding in-kind services, from this fund for the purposes of
7 promoting alumni relations and generating private donations for
8 deposit into the University of Hawaii Foundation for the
9 purposes of the university. Any expenditure authorized pursuant
10 to this subsection shall be for a public purpose and shall not
11 be subject to chapters 42F, 103, 103D, and 103F. The university
12 shall submit a comprehensive report to the legislature detailing
13 the use of any funds authorized by the board under this
14 subsection no later than twenty days prior to the convening of
15 each regular session.

16 The report shall:

- 17 (1) Identify each department of the University of Hawaii
18 Foundation supported by moneys from the fund;
- 19 (2) Describe the purposes and activities of each
20 department identified in paragraph (1) and how it



1 participates in fundraising activities and benefits
2 the university;

3 (3) Provide the total expenditures of each department
4 identified in paragraph (1) by primary expense
5 categories;

6 (4) Identify all moneys from the fund transferred to any
7 fund of the university and provide a justification of
8 how these moneys are used to benefit the university;

9 (5) Provide a financial summary of the operating
10 activities of the University of Hawaii Foundation,
11 including revenues and expenditures by major reporting
12 categories; and

13 (6) Identify amounts and purposes of all expenditures from
14 the University of Hawaii support fund.

15 (c) Any law to the contrary notwithstanding, the
16 university may transfer funds from the University of Hawaii
17 tuition and fees special fund into the scholarship and
18 assistance special fund established pursuant to section
19 304A-2159.

20 (d) In estimating its quarterly budget requirements, each
21 campus of the University of Hawaii shall prepare a plan for the



1 fiscal year for the operation of each of the programs that it is
2 responsible for administering. The operations plan shall be:

3 (1) In such form and content as the vice president for
4 budget and finance and chief financial officer of the
5 University of Hawaii may prescribe; and

6 (2) Submitted, together with the estimated quarterly
7 budget requirements, to the vice president for budget
8 and finance and chief financial officer on [~~such~~] a
9 date [~~as~~] that the vice president for budget and
10 finance and chief financial officer may prescribe.

11 (e) The president and vice president for budget and
12 finance and chief financial officer of the University of Hawaii:

13 (1) Shall review the operations plan for each campus to
14 determine if:

15 (A) It is consistent with the policy decisions of the
16 board of regents and appropriations by the
17 legislature;

18 (B) It reflects proper planning and efficient
19 management methods; and



1 (C) Appropriations have been made for the planned
2 purpose and will not be exhausted before the end
3 of the fiscal year;

4 (2) Shall approve the operations plan for each campus if
5 they determine that the operations plan meets the
6 requirements of paragraph (1); and

7 (3) May modify or withhold the planned expenditures of any
8 campus at any time during the appropriations period.

9 (f) At the end of each fiscal year, the moneys in the
10 University of Hawaii tuition and fees special fund for each
11 campus shall lapse to the credit of program identification
12 number UOH900 (University of Hawaii, system wide support).

13 (g) Notwithstanding any other law to the contrary, funds
14 expended from or originating from this fund for the University
15 of Hawaii school of medicine or the cancer research center of
16 Hawaii shall be used by the school of medicine or the cancer
17 research center of Hawaii for educational purposes only."

18 SECTION 9. Section 304A-2253, Hawaii Revised Statutes, is
19 amended to read as follows:

20 "**§304A-2253 Research and training revolving fund.** (a)
21 There is established a University of Hawaii research and



1 training revolving fund into which shall be deposited one
2 hundred per cent of the total amount of indirect overhead
3 revenues generated by the university from research and training
4 programs. The board of regents is authorized to expend one
5 hundred per cent of the revenues deposited in the fund for:

- 6 (1) Research and training purposes that may result in
7 additional research and training grants and contracts;
- 8 (2) Facilitating research and training at the university;
- 9 and
- 10 (3) Further deposit into the discoveries and inventions
11 special fund.

12 (b) The annual report required to be made for this
13 revolving fund shall include but not be limited to a breakdown
14 of travel expenses.

15 (c) Notwithstanding section 304A-107 to the contrary, the
16 board of regents, or its designee, may establish a separate
17 account within the research and training revolving fund for the
18 purpose of providing advance funding to meet reimbursable costs
19 incurred in connection with federally financed research and
20 training projects. Any reimbursement received as a result of
21 providing advance funding shall be deposited into the research



1 and training revolving fund to be used for the purpose of
2 meeting reimbursable costs incurred in connection with federally
3 financed projects.

4 (d) Revenues deposited into the fund shall not be used as
5 a basis for reducing any current or future budget request or
6 allotment to the university unless the university requests such
7 a reduction.

8 (e) Notwithstanding any other law to the contrary, funds
9 expended from or originating from this fund for the University
10 of Hawaii school of medicine or the cancer research center of
11 Hawaii shall be used by the school of medicine or the cancer
12 research center of Hawaii for research and research-related
13 purposes only."

14 PART IV

15 SECTION 10. Section 304A-2168, Hawaii Revised Statutes, is
16 amended by amending subsection (d) to read as follows:

17 "(d) Beginning on January 1, 2010, the University of
18 Hawaii shall report [~~semi-annually~~] to the legislature, no later
19 than twenty days prior to the convening of each regular session,
20 on the moneys in the Hawaii cancer research special fund,
21 including deposits, expenditures, and other transactions. The



1 [~~reports~~] report shall explain in detail all expenditures from
2 the special fund[-] for the preceding fiscal year."

State Finances; Special Funds; General Fund; Central Services Expenses; Reporting; UH; Cancer Center; JABSOM

Description:

Part I - By November 1 of each year, requires each department to submit program measures, costs elements, and accounting reports for all non-general funds to the Legislature. Part II - Makes certain special funds subject to deductions for central service expenses into the general fund. Beginning 7/1/2021 transfers to the credit of the general fund cigarette tax revenue allocated to the emergency medical services special fund. Specifies that the cigarette tax revenues deposited to the credit of the cancer research special fund shall only be used for capital expenditures and only until 7/1/2041. Ceases deposits of cigarette tax revenues into the emergency medical services special fund on 7/1/2021. Part III - Requires the cancer research center of Hawaii to be affiliated with the John A. Burns school of medicine with direct lines of reporting to the provost of University of Hawaii at Manoa and coordinate with the president of the university. Requires funds expended from the tuition and fees special fund for the John A. Burns school of medicine or cancer research center of Hawaii to be used for educational purposes only. Requires funds expended from the research and training revolving fund for the John A. Burns school of medicine and cancer research center of Hawaii to be used for research and research-related purposes only. Part IV - Amends the reporting requirement on the Hawaii cancer research special fund from semi-annually to annually. (SD2)
