
A BILL FOR AN ACT

RELATING TO CLIMATE CHANGE MITIGATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that vehicle emissions
2 are a direct contributor to global warming. Climate change
3 caused by greenhouse gas emissions from burning fossil fuels
4 poses a serious threat to the economic well-being, public
5 health, natural resources, and environment of Hawaii. The
6 potential adverse impacts of climate change include the
7 exacerbation of air-quality problems, a reduction in the quality
8 and supply of water, a rise in sea levels resulting in the
9 displacement of coastal businesses and residences, damage to
10 marine ecosystems and the natural environment, and an increase
11 in the incidences of infectious diseases, asthma, and other
12 human health-related problems.

13 The legislature further finds that rental motor vehicles
14 represent the largest passenger vehicle fleets in Hawaii and are
15 responsible for a significant amount of carbon emissions.
16 Imposing an emissions surcharge on these vehicles will provide
17 steady funding for the climate change mitigation and adaptation



1 commission to establish climate change mitigation and adaptation
2 strategies and goals to help guide planning and implementation
3 statewide in furtherance of the Hawaii 2050 sustainability plan.

4 The purpose of this Act is to address climate change by
5 establishing a rental motor vehicle emissions surcharge to
6 support the activities of the climate change mitigation and
7 adaptation commission.

8 SECTION 2. Chapter 225P, Hawaii Revised Statutes, is
9 amended by adding a new section to be appropriately designated
10 and to read as follows:

11 "§225P- Climate change mitigation and adaptation
12 commission special fund. (a) There is established in the state
13 treasury a climate change mitigation and adaptation commission
14 special fund, into which shall be deposited all moneys received
15 from any rates, fees, fines, and administrative penalties
16 pursuant to section 251- .

17 (b) Moneys in the climate change mitigation and adaptation
18 commission special fund shall be used by the commission to
19 support the commission's activities pursuant to this chapter."



1 SECTION 3. Chapter 251, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 **"§251- Rental motor vehicle emissions surcharge. (a)**

5 There is levied and shall be assessed and collected each month a
6 rental motor vehicle emissions surcharge of \$ _____ for
7 every twenty-four hours, or any portion thereof, that a rental
8 motor vehicle is rented or leased to a lessee; provided that the
9 rental motor vehicle emissions surcharge shall not be levied on:

10 (1) Any rental motor vehicle during the first twenty-four
11 hours that the rental motor vehicle is rented or
12 leased to a lessee;

13 (2) Any electric rental motor vehicle; or

14 (3) Any rental motor vehicle that is rented to a lessee to
15 replace a motor vehicle of the lessee that is being
16 repaired; provided that a record of the repair order
17 for the motor vehicle is retained either by the lessor
18 for two years for verification purposes or by a motor
19 vehicle repair dealer for two years as provided in
20 section 437B-16.



1 (b) The rental motor vehicle emissions surcharge shall be
2 levied upon the lessor.

3 (c) Notwithstanding section 251-5 or any other law to the
4 contrary, all moneys received from rates, fees, fines, and
5 administrative penalties of the rental motor vehicle emissions
6 surcharge shall be deposited into the climate change mitigation
7 and adaptation commission special fund established pursuant to
8 section 225P- ."

9 SECTION 4. New statutory material is underscored.

10 SECTION 5. This Act shall take effect on July 1, 2021.
