

A BILL FOR AN ACT

RELATING TO CITATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 291, Hawaii Revised Statutes, is 2 amended by adding a new section to part I to be appropriately 3 designated and to read as follows:
- "\$291- ___ Electronic citation surcharge. (a) In addition 4 5 to any other civil penalties ordered by the court, a person who 6 violates any provision under this part shall be ordered to pay 7 an electronic citation surcharge of \$5.
- (b) The person shall pay the surcharge to the clerk of the 9 court. The surcharge shall be deposited with the director of 10 finance, who shall credit the surcharge to the electronic 11 citation special fund established under section 291C-C."

SECTION 2. Chapter 291C, Hawaii Revised Statutes, is

3	"Electronic citation" means the process of transmitting
4	traffic, misdemeanor, or other citations and law enforcement
5	data via electronic means to the clerk of the court.
6	§291C-B Electronic citation surcharge. (a) In addition
7	to any other civil penalties ordered by the court, a person who
8	violates any provision under this chapter shall be ordered to
9	pay an electronic citation surcharge of \$5.
10	(b) The person shall pay the surcharge to the clerk of the
11	court, who shall credit the surcharge to the electronic citation
12	special fund established under section 291C-C.
13	§291C-C Electronic citation program; electronic citation
14	special fund; establishment. (a) There is established, within
15	the judiciary, an electronic citation program. This program
16	shall be funded and sustained through the electronic citation
17	special fund.

(b) There is established in the state treasury the

electronic citation special fund, into which shall be deposited:

8	(c)	Moneys in the electronic citation special fund shall										
9	be distributed by the judiciary, in accordance with rules											
10	adopted pursuant to subsection (d), to the respective county											
11	police departments and clerk of the court to defray expenses											
12	related to the establishment and maintenance of the electronic											
13	citation	program.										
14	(d)	The judiciary shall adopt rules pursuant to chapter 91										
15	to implem	ent this section. The rules shall establish a formula										
16	by which	the moneys in the electronic citation special fund										
17	shall be	distributed to the respective law enforcement agencies										
18	and to the administrative director of the courts and provide how											
19	each shall expend the moneys for the purposes of an electronic											
20	citation program."											

1 SECTION 3. Section 291D-9, Hawaii Revised Statutes, is 2 amended by amending subsection (c) to read as follows: 3 "(c) In addition to any monetary assessment imposed for a traffic infraction and the cost for an electronic citation 5 surcharge, the court may impose additional assessments for: 6 (1)Failure to pay a monetary assessment by the scheduled 7 date of payment; or (2) The cost of service of a penal summons issued pursuant 9 to this chapter." 10 SECTION 4. There is appropriated out of the general 11 revenues of the State of Hawaii the sum of \$ 12 much thereof as may be necessary for fiscal year 2021-2022 for start-up costs associated with the electronic citation program. 13 14 The sum appropriated shall be expended by the judiciary for 15 the purposes of this Act. SECTION 5. In codifying the new sections added by section 16 17 2 of this Act, the revisor of statutes shall substitute 18 appropriate section numbers for the letters used in designating 19 the new sections in this Act.
