A BILL FOR AN ACT

RELATING TO THE INFORMATION TECHNOLOGY STEERING COMMITTEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that members of the
- 2 information technology steering committee have a wealth of
- 3 institutional knowledge regarding the State's complex
- 4 information systems. It is therefore in the best interests of
- 5 the public to allow the members of the information technology
- 6 steering committee to serve without term limits so their
- 7 institutional knowledge can continue to assist the chief
- 8 information officer in developing the State's information
- 9 technology standards and policies. Additionally, the
- 10 legislature finds that it is in the best interests of the public
- 11 for the superintendent of education and president of the
- 12 University of Hawaii to be able to appoint members to the
- 13 information technology steering committee. Finally, to ensure
- 14 both accountability and transparency, the legislature believes
- 15 that the information technology steering committee should
- 16 publicly receive the annual report of the office of enterprise
