A BILL FOR AN ACT

RELATING TO FIREWORKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, despite the
- 2 potential for fines and arrest for the illegal use of fireworks,
- 3 individuals continue to break the law concerning the lawful use
- 4 of fireworks.
- 5 The legislature further finds that eighty per cent of fines
- 6 collected by courts for violations of the Fireworks Control Law
- 7 is required to be allocated to the counties for purposes of law
- 8 enforcement, while twenty per cent is allocated to the State.
- 9 By increasing these fines, the police departments may have
- 10 greater incentive to enforce those laws.
- 11 The purpose of this Act is to increase compliance
- 12 enforcement of the fireworks law by increasing the fines
- 13 associated with the illegal use of consumer fireworks and
- 14 display fireworks, articles pyrotechnic, and aerial devices
- 15 outside of the times permitted by law.
- 16 SECTION 2. Section 132D-14, Hawaii Revised Statutes, is
- 17 amended by amending subsection (b) to read as follows:

- 1 "(b) Except as provided in subsection (a) or as otherwise
- 2 specifically provided for in this chapter, any person violating
- 3 any other provision of this chapter $[\tau]$ shall be fined not more
- 4 than \$2,000 for each violation[-]; provided that any person
- 5 violating section 132D-3 or 132D-4(b) shall be fined not more
- 6 than \$4,000 for each violation. Notwithstanding any provision
- 7 to the contrary in this section, any person violating section
- 8 132D-14.5 shall be fined at least \$500 and no more than
- 9 \$2,000[-]; provided that when the violation involves aerial
- 10 devices which are set off, ignited, or otherwise caused to
- 11 explode outside of the hours permitted by section 132D-4(b), the
- 12 fine shall be at least \$1,000 and no more than \$4,000."
- 13 SECTION 2. This Act does not affect rights and duties that
- 14 matured, penalties that were incurred, and proceedings that were
- 15 begun before its effective date.
- 16 SECTION 3. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
