A BILL FOR AN ACT

RELATING TO THE PROTECTION OF SHARKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sharks, known as
- 2 "mano" in the Hawaiian language, are extremely important to
- 3 ocean ecosystems. As ocean predators near the top of the food
- 4 chain, sharks keep the ecosystem balanced, regulate populations
- 5 of other marine life, and ensure healthy fish stock and reefs.
- 6 The legislature also finds that sharks are more vulnerable
- 7 than most other fish species. They are long-lived and
- 8 slow-growing, start reproducing at an advanced age, and produce
- 9 relatively few offspring per year. If the food chain is
- 10 disrupted by a decline in the shark population, it affects the
- 11 entire reef system. Protection for sharks ultimately means
- 12 healthier, more resilient oceans and reefs that are better able
- 13 to withstand other pressures on the ocean ecosystem from climate
- 14 change and pollution.
- The legislature further finds that sharks on the reefs not
- 16 only play important ecological roles, but are also valued
- 17 figures in Hawaiian culture. The benefits of maintaining viable



- 1 populations greatly outweigh any value that would be gained by
- 2 killing these species.
- 3 The purpose of this Act is to protect sharks for their
- 4 ecological value and for their value to native Hawaiian cultural
- 5 practices.
- 6 SECTION 2. Chapter 188, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:
- 9 "S188- Sharks; mano; prohibitions; exceptions; penalties
- 10 and fines. (a) Except as provided in subsection (e), or as
- 11 otherwise provided by law, no person shall knowingly capture or
- 12 entangle any shark, whether alive or dead, or kill any shark,
- 13 within state marine waters.
- 14 (b) Any person violating this section or any rule adopted
- 15 pursuant to this section shall be guilty of a misdemeanor;
- 16 provided that the fine for violating this section shall be:
- 17 (1) \$500 for a first offense;
- 18 (2) \$2,000 for a second offense; and
- 19 (3) \$10,000 for a third or subsequent offense.
- 20 (c) In addition to any other penalty imposed under this
- 21 section, a person violating this section shall be subject to:

1	(1)	An administrative fine of no more than \$10,000 for
2		each shark captured, entangled, whether alive or dead,
3		or killed in violation of this section;
4	(2)	Seizure and forfeiture of any captured sharks or any
5		part or product therefrom, commercial marine license,
6		vessel, and fishing equipment; and
7	(3)	Assessment of administrative fees and costs, and
8		attorney's fees and costs.
9	(d)	The criminal penalties and administrative fines, fees,
10	and costs	shall be assessed per shark captured, entangled,
11	whether d	ead or alive, or killed in violation of this section.
12	(e)	This section shall not apply to:
13	(1)	Special activity permits issued under section 187A-6
14		or any person who holds a license or permit issued by
15		the department to conduct research;
16	(2)	The department of land and natural resources or its
17		designated agent if the capture, entanglement, whether
18		alive or dead, or killing is for the protection of
19		<pre>public safety;</pre>
20	(3)	Sharks taken outside of state marine waters and
21		possessed on a vessel in state marine waters pursuant

1		to any federally managed fishery, with the required	
2		documentation of the location where the capture	
3		occurred; and	
4	(4)	Any person if the capture, entanglement, whether alive	
5		or dead, or killing is the result of defense of the	
6		person's self or of another against death or bodily	
7		harm.	
8	<u>(f)</u>	Nothing in this section shall be construed to restrict	
9	the exercise of traditional and customary rights protected		
10	pursuant to article XII, section 7, of the Hawaii State		
11	Constitution.		
12	(g)	For the purposes of this section, "shark" means any	
13	species c	of shark within the subclass Elasmobranchii."	
14	SECT	ION 3. Section 188-70, Hawaii Revised Statutes, is	
15	amended b	y amending subsection (a) to read as follows:	
16	"(a)	Any person violating any provision of or any rule	
17	adopted pursuant to this chapter, except sections 188-23 [and]_		
18	188-39.5,	and 188- , is guilty of a petty misdemeanor and, in	
19	addition	to any other penalties, shall be fined not less than:	
20	(1)	\$100 for a first offense;	
21	(2)	\$200 for a second offense; and	

- 1 (3) \$500 for a third or subsequent offense."
- 2 SECTION 4. This Act does not affect rights and duties that
- 3 matured, penalties that were incurred, and proceedings that were
- 4 begun before its effective date.
- 5 SECTION 5. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect upon its approval.
