A BILL FOR AN ACT

RELATING TO CHILDLIKE SEX DOLLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the widespread
- 2 availability of childlike sex dolls enables the exploitation,
- 3 objectification, abuse, and sexual assault of children.
- 4 Childlike sex dolls are designed to look and feel as lifelike as
- 5 possible. The physical features of these dolls resemble those
- 6 of minor children; some dolls are accompanied by accessories
- 7 such as wigs and false eyelashes. Childlike sex dolls may have
- 8 robotic properties that simulate a real child's emotions such as
- 9 sadness or fear and may also include a programmable "rape
- 10 function".
- 11 The legislature recognizes that possession of a childlike
- 12 sex doll correlates with other offenses perpetrated against
- 13 children. For example, in the United Kingdom, where multiple
- 14 shipments of childlike sex dolls have been seized by border
- 15 patrol agents, investigators found that in many cases the dolls
- 16 were addressed to individuals committing other offenses
- 17 involving harm to children. Similarly, a Johns Hopkins School

- 1 of Medicine paraphilia researcher has opined that contact with a
- 2 childlike sex doll is likely to reinforce pedophilic thoughts
- 3 and cause those thoughts to be acted upon with greater urgency.
- 4 Moreover, the legislature believes that some users of childlike
- 5 sex dolls will reach a point where interaction with a doll is no
- 6 longer satisfactory and thus attempt to engage in sexual
- 7 activities with a human child.
- 8 The legislature also finds that other jurisdictions have
- 9 taken action to help protect children from the harm associated
- 10 with childlike sex dolls. Florida and Tennessee have enacted
- 11 laws that impose criminal penalties for selling or possessing a
- 12 childlike sex doll. Similar measures were introduced in the
- 13 legislatures of Georgia and New Jersey in 2020. Further,
- 14 measures criminalizing the importation, transportation, sale,
- 15 and possession of childlike sex dolls have been introduced in
- 16 the United States Congress in recent years. A current example
- 17 is H.R. 8236, also known as the "Curbing Realistic Exploitative
- 18 Electronic Pedophilic Robots Act 2.0" (CREEPER Act 2.0), which
- 19 was introduced in the House of Representatives on September 14,
- 20 2020.

1	The purpose of this Act is to establish the felony offense
2	of importation, sale, or possession of a childlike sex doll.
3	SECTION 2. Chapter 712, Hawaii Revised Statutes, is
4	amended by adding a new section to part II to be appropriately
5	designated and to read as follows:
6	"§712- Importation, sale, or possession of a childlike
7	sex doll. (1) A person commits the offense of importation,
8	sale, or possession of a childlike sex doll if the person
9	intentionally, knowingly, or recklessly:
10	(a) Imports or causes to be imported into the State a
11	childlike sex doll;
12	(b) Sells, offers to sell, distributes, or otherwise
13	provides to another person a childlike sex doll; or
14	(c) Possesses a childlike sex doll.
15	(2) The importation, sale, or possession of five or fewer
16	childlike sex dolls is a class C felony.
17	(3) The importation, sale, or possession of more than five
18	childlike sex dolls is a class B felony.
19	(4) For purposes of this section, "childlike sex doll"
20	means a doll, mannequin, or robot that is intended for sexual
21	stimulation or gratification and that has the features of, or

- 1 features that resemble those of, a person below the age of
- 2 eighteen years."
- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect on January 1, 2050.
