A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that events, including
- 2 the coronavirus disease 2019 (COVID-19) pandemic that began in
- 3 2019, can have long-lasting financial and fiscal impacts on the
- 4 State. With decreased tax revenues and economic activity,
- 5 furloughs or mandatory pay reductions may be deemed necessary.
- 6 Accordingly, the purpose of this Act is to ensure that
- 7 furloughs and pay reductions do not affect the base pay utilized
- 8 in the calculation of retirement benefits for eligible
- 9 employees.
- 10 SECTION 2. Section 88-21, Hawaii Revised Statutes, is
- 11 amended by amending the definition of "base pay" to read as
- 12 follows:
- ""Base pay" means the normal periodic payments of money for
- 14 service, the right to which accrues on a regular basis in
- 15 proportion to the service performed [+], unreduced by any
- 16 furloughs or mandatory pay reduction; recurring differentials;
- 17 and elective salary reduction contributions under sections 125,

- 1 403(b), and 457(b) of the Internal Revenue Code of 1986, as
- 2 amended."
- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on July 1, 2021.
