A BILL FOR AN ACT

RELATING TO CORRECTIONAL FACILITY AND COMMUNITY CORRECTIONAL CENTER DEATHS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the public has a 2 compelling interest in the timely reporting of the deaths of 3 inmates and others at the State's correctional facilities and 4 community correctional centers. This compelling interest 5 includes oversight responsibilities of the legislature. 6 The purpose of this Act is to update the reporting requirements of the department of public safety when inmate and 7 8 employee deaths occur at correctional facilities and community 9 correctional centers, including: 10 (1)Requiring the race of the decedent to be included in 11 the report; 12 (2) Requiring the report to cite any authority relied upon 13 by the director of public safety in determining that

1 (c) Within thirty days of a death described in 2 subsection (a), the director shall submit a report to the 3 governor, and the governor shall submit the report to the 4 legislature, of the clinical mortality review conducted in 5 response to the death, including correctional actions to be 6 taken. 7 The director shall not have the discretion to withhold 8 disclosure of the decedent's name or any information, unless the 9 name or information is otherwise protected from disclosure by 10 state or federal laws[-]; provided that the report shall cite 11 the state or federal law the director relied upon to withhold 12 disclosure. 13 (e) Upon receipt of the report from the medical examiner, 14 the director shall make a copy of the report required by 15 subsection (a) public and readily available first to the family 16 member or other person designated by the decedent and then to 17 the press; provided that the director may withhold information 18 related to an ongoing criminal investigation and prosecution or 19 information that shall otherwise remain confidential in order to 20 avoid the frustration of a legitimate government function.

- 2 means the decedent's spouse or reciprocal beneficiary, as
- 3 defined in section 572C-3, and any child, parent, grandparent,
- 4 or sibling of the decedent, and the spouses or reciprocal

- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect on July 1, 3050.

Correctional Inmates and Employees; Deaths; Reporting; PSD

Description:

Updates reporting requirements by the PSD when inmate and employee deaths occur at correctional facilities and community correctional centers. Requires the report to include the race of the decedent. Requires the report to cite to any authority relied upon by the PSD in determining that information is protected by state or federal law. Provides for disclosure of the report, subject to certain conditions. Effective 7/1/3050. (HD2)
