### A BILL FOR AN ACT

RELATING TO FORESTRY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that under the Hawaii
- 2 sustainability initiative, the State has committed to integrated
- 3 sustainability goals, including increasing the State's climate
- 4 resiliency, as well as supporting and increasing local food
- 5 production.
- 6 The legislature further finds that numerous sources, both
- 7 internationally and nationally, have recognized the importance
- 8 of healthy soil as a critical resource for supplying food
- 9 security, diverse habitats, water storage, and climate
- 10 resiliency. For example, the Food and Agriculture Organization
- 11 of the United Nations, nations around the world, and other
- 12 agencies including the United States Department of Agriculture,
- 13 celebrated 2015 as the International Year of Soils to highlight
- 14 the necessity of healthy soil for food security and ecosystem
- 15 resilience against climate change. Similarly, in recognition of
- 16 the importance of healthy soil to climate resiliency and food
- 17 security, many states around the country have launched

- 1 initiatives to incentivize building soil organic matter and
- 2 improving soil health.
- 3 The legislature also finds that trees have an important
- 4 function in improving soil health and building climate
- 5 resiliency for Hawaii's environment, including its agricultural
- 6 landscapes. The Natural Resources Conservation Service, a
- 7 division of the United States Department of Agriculture, has
- 8 identified agroforestry as a unique land management approach
- 9 that intentionally blends agriculture and forestry to enhance
- 10 productivity, profitability, and environmental stewardship.
- 11 According to the Natural Resources Conservation Service,
- 12 the strategic planting of trees in agricultural landscapes may
- 13 increase crop yield, improve soil health, provide habitat for
- 14 wildlife, and provide a variety of other benefits.
- 15 The division of forestry and wildlife of the department of
- 16 land and natural resources manages four state tree nurseries
- 17 that aim to provide high quality native, endangered, and
- 18 windbreak trees and plants for the public and department of land
- 19 and natural resources plantings and reforestation projects.
- The legislature further finds that there is a need to
- 21 repair, update, and expand the resources available to the state

- 1 tree nurseries, including by increasing the available selections
- 2 of trees and plants that provide beneficial functions in
- 3 agricultural production.
- 4 The legislature further finds that various tree nurseries
- 5 across the State need facilities or improvements. The Waimea-
- 6 Kamuela state tree nursery is the largest facility, meant to
- 7 service large scale projects statewide. The facility requires a
- 8 greenhouse, irrigation, and seed cleaner system to ensure
- 9 seedling sanitation to resume statewide supply, which has been
- 10 halted over concerns over seedling exposure to surrounding
- 11 invasive species in a windy location. The Maui and Kauai
- 12 district nurseries also require greenhouses and irrigation.
- 13 While the Kauai district mid-elevation rare plant nursery needs
- 14 water catchment and expansion of the greenhouse. The Oahu
- 15 district nursey requires a storage shed, access ramp, and
- 16 construction of a structure for plant processing.
- 17 The purpose of this Act is to authorize the issuance of
- 18 general obligation bonds for the forest stewardship program to
- 19 increase the existing plant stocks, invest in public outreach,
- 20 and renovate the equipment and facilities of the state tree
- 21 nurseries.

1	SECT	ION 2. The director of finance is authorized to issue
2	general o	bligation bonds in the sum of \$1,380,000 or so much
3	thereof a	s may be necessary and the same sum or so much thereof
4	as may be	necessary is appropriated for fiscal year 2021-2022
5	for the p	urpose of the forest stewardship program to:
6	(1)	Work in collaboration with appropriate stakeholders,
7		including but not limited to the greenhouse gas
8		sequestration task force, researchers from the college
9		of tropical agriculture and human resources of the
10		university of Hawaii, and the United States Department
11		of Agriculture National Resource Conservation Service,
12		to expand and increase the existing plant stocks of
13		the state tree nurseries to include a wider range of
14		native trees and plant species identified by the
15		division of forestry and wildlife to be beneficial in
16		agricultural settings for improving agricultural
17		productivity and improving soil health;
18	(2)	Renovate and update the equipment and facilities of
19		the state tree nurseries to expand their capacity to
20		provide clean planting materials for a variety of
21		public and private projects; and

5	The sum appropriated shall be expended by the department of		
6	land and natural resources for the purposes of this Act.		
7	SECTION 3. The appropriation made for the capital		
8	improvement project authorized by this Act shall not lapse at		
9	the end of the fiscal biennium for which the appropriation is		
10	made; provided that all moneys from the appropriation		
11	unencumbered as of June 30, 2024, shall lapse as of that date.		
12	SECTION 4. This Act shall take effect on July 1, 2021.
