DEPARTMENT:

Business, Economic Development, and Tourism

TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII BROADBAND AND DIGITAL EQUITY OFFICE.

PURPOSE:

Establish the Hawaii Broadband and Digital Equity Office within the Department of Business, Economic Development, and Tourism.

MEANS:

Add a new chapter to the Hawaii Revised Statutes.

JUSTIFICATION:

Hawaii was not prepared for the first stayat-home, work-from-home orders triggered by the COVID-19 pandemic. From day one, local government, businesses, educators, and residents felt Hawaii's vulnerability due to the inadequacy of digital infrastructure that we had otherwise taken for granted. Broadband and its related facets of access, literacy, applications like telehealth, remote work and distance learning, and the economy became among the State's most pressing challenges. This bill establishes a State focus on broadband and digital equity and accesses various funding sources. including federal programs, to build broadband infrastructure and implement digital equity programs.

Impact on the public: It is widely recognized that building robust broadband infrastructure and eliminating digital inequity benefit all Hawaii residents. This is the foundation upon which Hawaii can survive and thrive in the twenty-first century digital economy.
