BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 121-39, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§121-39 Pay of officers and warrant officers while on
4	active duty. Officers and warrant officers of the [army or air
5	national guard] Army or Air National Guard while on active duty
6	of the State shall receive the pay and allowances of officers
7	and warrant officers of similar grades of the United States Army
8	and Air Force, respectively; provided that:
9	(1) The State shall allow officers and warrant officers to
10	directly deposit their pay by electronic means to
11	their personal banking accounts; [and]
12	(2) If officers and warrant officers are activated for
13	more than thirty days, the State shall provide
14	allowances for the payment of Tricare Reserve Select
15	or other government-funded medical insurance for the
16	individual officer and the officer's family should the
17	officer have eligible dependents; and

1	$\left[\frac{(2)}{(3)}\right]$ No pay or allowances shall be made to officers or
2	warrant officers for any service for which they
3	receive military pay and allowances from the United
4	States."
5	SECTION 2. Section 121-40, Hawaii Revised Statutes, is
6	amended to read as follows:
7	"§121-40 Pay of enlisted personnel while on active duty.
8	Enlisted personnel of the [army and air national guard] Army and
9	Air National Guard while on active duty in the service of the
10	State, except during periods of annual field training or year-
11	round field training, shall receive the same pay and allowances
12	as enlisted personnel of similar rank in the United States Army
13	and Air Force respectively; provided that the:
14	(1) State shall allow enlisted personnel to directly
15	deposit their pay by electronic means to their
16	personal banking accounts; [and]
17	(2) If officers and warrant officers are activated for
18	more than thirty days, the State shall provide
19	allowances for the payment of Tricare Reserve Select
20	or other government-funded medical insurance for the

1	individual officer and the officer's family should the
2	officer have eligible dependents; and
3	$[\frac{(2)}{(3)}]$ Aggregate of the pay and allowances, computed on
4	a daily basis, shall in no event be less than the
5	amount equal to ten times the hourly wage specified in
6	section 387-2."
7	SECTION 3. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 4. This Act shall take effect on July 1, 3050.
