
HOUSE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF THE GOVERNOR TO CONVENE A TASK FORCE TO ASSESS WHETHER STATE AGENCIES' ANTI-BULLYING POLICIES AND RECORDS OF INCIDENCES OF BULLYING ARE PROPERLY UPDATED AND EFFECTIVELY UTILIZED.

1 WHEREAS, all students have the right to fully participate
2 in the educational process free from bullying, including
3 cyberbullying and harassment; and
4

5 WHEREAS, a safe and civil environment is necessary for
6 students to learn and meet high academic standards; and
7

8 WHEREAS, because of the central role that data collection
9 occupies in virtually every aspect of government decision-making
10 and resource allocation, failure to maintain accurate
11 demographic data brings about very real and dire consequences
12 for youth; and
13

14 WHEREAS, there must be an evaluation of the effectiveness
15 of current anti-bullying measures at the district and individual
16 school level; and
17

18 WHEREAS, implementing new policies that focus on
19 progressive rather than punitive punishments for students that
20 have committed acts of bullying, cyberbullying, or harassment
21 should be prioritized; and
22

23 WHEREAS, the State supports the right for all students,
24 regardless of race, gender identity or expression, religion,
25 disability, ancestry, or sexual orientation, to learn in a safe
26 environment free from bullying, cyberbullying, and harassment;
27 now, therefore,



1 BE IT RESOLVED by the House of Representatives of the
2 Thirty-first Legislature of the State of Hawaii, Regular Session
3 of 2021, the Senate concurring, that the Office of the Governor
4 is requested to convene a task force to assess whether state
5 agencies' anti-bullying policies and records of incidences of
6 bullying are properly updated and effectively utilized; and
7

8 BE IT FURTHER RESOLVED that the Office of the Governor is
9 requested to convene the task force with one representative from
10 the following agencies with experience and expertise in lesbian,
11 gay, bisexual, transgender, queer/questioning, intersex,
12 asexual, and pansexual (LGBTQ+) issues:
13

- 14 (1) Department of Education;
- 15 (2) Department of Human Services;
- 16 (3) Department of Transportation;
- 17 (4) Department of Health;
- 18 (5) State Public Charter School Commission; and
- 19 (6) University of Hawaii; and

20 BE IT FURTHER RESOLVED that the task force is requested to
21 invite other individuals with relevant experience and expertise
22 to be members of the task force, including:
23

- 24 (1) Youth advocates;
- 25 (2) Teachers;
- 26 (3) Youth;
- 27 (4) Direct services providers; and
- 28 (5) Parents and legal guardians; and

29 BE IT FURTHER RESOLVED that the task force is requested to
30 develop model policy related to all forms of bullying, including
31 cyberbullying and harassment; and

1 BE IT FURTHER RESOLVED that the state agencies with
2 representation on the task force are requested to provide the
3 task force with reports and information recorded on incidences
4 of bullying; and

5
6 BE IT FURTHER RESOLVED that the task force is requested to
7 provide, when possible, recommendations on changes to curricula
8 that are meant to reduce bullying and promote civil conduct
9 through education on the following enumerations:

- 10
11 (1) Race or color;
12
13 (2) Gender identity or expression;
14
15 (3) Religion;
16
17 (4) Disability;
18
19 (5) Ancestry or national origin; and
20
21 (6) Sexual Orientation; and
22

23 BE IT FURTHER RESOLVED that the task force is requested to
24 consider that students who have committed acts of bullying,
25 cyberbullying, or harassment be given non-punitive actions that
26 are meant to address the root causes of bullying, including but
27 not limited to:

- 28
29 (1) Meeting with parents;
30
31 (2) Reflective writing;

33 (3) Counseling;

35 (4) Health counseling or intervention;

37 (5) Mental health counseling;

39 (6) Participation in skills building and resolution
40 activities;



1 (7) Trauma-informed care; and

3 (8) Restorative justice programs; and

5 BE IT FURTHER RESOLVED that the Office of the Governor is
6 requested to appoint all members of the task force no later than
7 thirty days after the last day of the Regular Session of 2021;
8 and

9
10 BE IT FURTHER RESOLVED that the members of the task force
11 shall serve without compensation and shall receive no
12 reimbursement for expenses; and

13
14 BE IT FURTHER RESOLVED that the task force is requested to
15 convene its initial meeting within sixty days after the
16 appointment of the last member of the task force; and

17
18 BE IT FURTHER RESOLVED that the task force is requested to
19 submit a report of its findings and recommendations, including
20 any proposed legislation, to the Legislature no later than
21 twenty days prior to the convening of the Regular Session of
22 2023; and

23
24 BE IT FURTHER RESOLVED that certified copies of this
25 Concurrent Resolution be transmitted to the Governor,
26 Superintendent of Education, Director of Human Services,
27 Director of Transportation, Director of Health, President of the
28 University of Hawaii, Chairperson of the Board of Education, and
29 Executive Director of the State Public Charter School
30 Commission.
