
HOUSE RESOLUTION

REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO CONDUCT A STUDY
TO CREATE A STATUTORY DEFINITION OF CREATIVE WORKERS AND
DEVELOP RECOMMENDATIONS ON HOW THE TRANSIENT ACCOMMODATIONS
TAX MAY BE USED TO ASSIST CREATIVE WORKERS.

1 WHEREAS, the COVID-19 pandemic has negatively impacted the
2 State's economy, particularly in the tourism industry; and
3

4 WHEREAS, because of the decreased number of tourists,
5 Hawaii's creative artists have also suffered; and
6

7 WHEREAS, tourists who come to Hawaii have historically
8 enjoyed the art produced by Hawaii's creative artists; and
9

10 WHEREAS, it would be in the State's best interests to
11 leverage tourist dollars to support the creative arts; now,
12 therefore,

14 BE IT RESOLVED by the House of Representatives of the
15 Thirty-first Legislature of the State of Hawaii, Regular Session
16 of 2021, that the Legislative Reference Bureau is requested to
17 conduct a study to create a statutory definition of creative
18 workers and develop recommendations on how the Transient
19 Accommodations Tax may be used to assist creative workers; and

21 BE IT FURTHER RESOLVED that when conducting the study, the
22 Legislative Reference Bureau is urged to consult with the
23 Department of Business, Economic Development, and Tourism;
24 Department of Taxation; Department of Commerce and Consumer
25 Affairs; Department of Labor and Industrial Relations; Hawaii
26 Tourism Authority; Hawaii State Foundation on Culture and the
27 Arts; and Hawaii Arts Alliance; and

29 BE IT FURTHER RESOLVED that the Legislative Reference
30 Bureau is requested to submit a report, including any
31 recommendations and proposed legislation, to the Legislature no



1 later than twenty days prior to the convening of the
2 2022 Regular Session; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 Resolution be transmitted to the Director of Business, Economic
6 Development, and Tourism; Director of Taxation; Director of
7 Commerce and Consumer Affairs; Director of Labor and Industrial
8 Relations; President and Chief Executive Officer of the Hawaii
9 Tourism Authority; Executive Director of Hawaii State Foundation
10 on Culture and the Arts; Director of the Legislative Reference
11 Bureau; and Executive Director of the Hawaii Arts Alliance.
