Re: Hawaii Revised Statutes § 37-52.5 (a) – administratively established new accounts

Dear President Kouchi and Speaker Saiki:

As required by HRS § 37-52.5(a), the Judiciary respectfully submits this report to the Legislature on the following administratively established new accounts:

Account No. S-21-224-J Judiciary Electronic Citation Traffic Records -- \$61,340.00

Justification for the establishment of the account or fund: To enable the Judiciary Traffic Violations Bureau (TVB) for First and Second Circuits to continue to receive electronic citations (eCitations) from their respective police departments -- the Honolulu Police Department (HPD) and the Maui Police Department (MPD). eCitations help reduce paper transport delays and provide immediate access to citation data to the courts, prosecutors, and police departments.

Source of revenue: National Highway Traffic Safety Administration FAST Act Section 405c/402 program funds, through Hawaii DOT CFDA No.: 20.600 and 20.616.

Account No. S-21-225-J Judiciary Training -- \$46,830.00

Justification for the establishment of the account or fund: Training sessions for District Court Judges on impaired driving and highway safety issues, to increase their knowledge about the latest developments in the adjudication of traffic cases.

Source of revenue for the fund: National Highway Traffic Safety Administration FAST Act Section 154/164/405d program funds, through Hawaii DOT CFDA No.: 20.607/20.608/20.616.

Account No. S-21-226-J Judiciary DWI Court -- \$66,317.00

Justification for the establishment of the account or fund: To support the operation of the DWI Court Program in the District Court of the First Circuit by enhancing resources and increasing training opportunities to the program staff.

Source of revenue for the fund: National Highway Traffic Safety Administration FAST Act Section 154/164/405d program funds, through Hawaii DOT CFDA No.: 20.607/20.608/20.616.
