A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the coronavirus
- 2 disease 2019 pandemic has required many state employees to work
- 3 from home or other remote locations to maintain social
- 4 distancing and prevent the spread of the SARS-CoV-2 virus.
- 5 However, the relocation of state employees to non-traditional
- 6 work environments has left an indelible impression on the
- 7 possibilities of how state work can be accomplished.
- 8 The legislature also finds that working from home or other
- 9 off-worksite locations has demonstrated cost-effectiveness and
- 10 productivity in rendering public services. Remote teleworking
- 11 can and should continue to remain an important option for state
- 12 employees who can accomplish their duties outside of their
- 13 traditional work environment. Social distancing and decreasing
- 14 employees' physical presence in state facilities can continue to
- 15 provide a defense against the spread of infectious disease as
- 16 well as enable more cost-efficient use of state office
- 17 facilities.



- 1 The legislature has determined that employees working
- 2 off-site enables the State to make better use of its limited
- 3 resources, including but not limited to office space,
- 4 furnishing, equipment, electrical and data requirements, storage
- 5 space, and other traditional needs of employees who work at
- 6 state facilities. Employees who can accomplish the same work
- 7 from an off-site location may prefer to work at home to
- 8 accommodate the caregiving of keiki and kupuna. These
- 9 considerations can result in a win-win outcome for taxpayers and
- 10 state employees.
- 11 The purpose of this Act is to require the office of
- 12 enterprise technology services to establish policies and work
- 13 with departments and agencies to provide infrastructure and
- 14 resources to permit authorized state employees teleworking from
- 15 home or other off-worksite locations to securely access remote
- 16 computing services.
- 17 SECTION 2. Section 27-43, Hawaii Revised Statutes, is
- 18 amended by amending subsection (a) to read as follows:
- 19 "(a) There is established within the department of
- 20 accounting and general services the office of enterprise
- 21 technology services, which shall be headed by a full-time chief



- 1 information officer to organize, manage, and oversee statewide
- 2 information technology governance. The chief information
- 3 officer shall be appointed by the governor as provided in
- 4 section 26-34. The chief information officer shall report
- 5 directly to the governor and shall:
- (1) Develop, implement, and manage statewide information
 technology governance;
- 8 (2) Develop, implement, and manage the state information9 technology strategic plans;
- 10 (3) Develop and implement statewide technology standards;
- 11 (4) Work with each executive branch department and agency
 12 to develop and maintain its respective multi-year
 13 information technology strategic and tactical plans
 14 and road maps that are part of the State's overall
 15 information technology strategic plans, road maps, and
 16 directions;
- 17 (5) Coordinate each executive branch department and
 18 agency's information technology budget request,
 19 forecast, and procurement purchase to ensure
 20 compliance with the department or agency's strategic
 21 plan and road map and with the office of enterprise
