**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

6 from the respective funds.

7 SECTION 14. Funds appropriated or authorized by this Act  
8 that are not expended or encumbered by June 30, 2022, and  
9 June 30, 2023, of the respective fiscal years, shall lapse as of  
10 those dates.

11 SECTION 15. This Act shall take effect on July 1, 2050.
