(a) There is established the 5 conference center revolving fund for [the] conference center 6 [program in the college of continuing education and community 7 service of] programs conducted by the University of Hawaii at 8 Hilo. All fees, charges, and other moneys collected in 9 conjunction with the conference center [program] programs shall 10 be deposited in the revolving fund. The [dean of the college of 11 continuing education and community service] chancellor of the 12 University of Hawaii at Hilo or the chancellor's designee is 13 authorized to expend funds from the revolving fund for all costs 14 associated with conducting conferences, seminars, and courses by 15 the conference center [programs, including but not 16 limited to expenses for honoraria, hotel and room rentals, food 17 and refreshment, printing and mailing, airfare and per diem, 18 [leis,] lei, rental of audiovisual equipment, and conference

3	(b) The chancellor of the University of Hawaii at Hilo
4	shall submit a report to the legislature, no later than twenty
