A BILL FOR AN ACT

RELATING TO THE COMMISSION FOR NATIONAL AND COMMUNITY SERVICE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 90D-2, Hawaii Revised Statutes, is
2 amended to read as follows:

3 " [†] §90D-2 **Commission for national and community service;**
4 **establishment.** [†] There is established within the [University
5 ~~of Hawaii,~~] department of business, economic development, and
6 tourism, for administrative purposes only, the [†] commission for
7 national and community service [†] to:

- 8 (1) Encourage community service and volunteer
9 participation as a means of community and state
10 problem-solving;
- 11 (2) Promote and support voluntary citizen involvement in
12 government and private programs throughout the State;
- 13 (3) Develop a long-term, comprehensive vision and plan for
14 action for community service initiatives in Hawaii;
15 and
- 16 (4) Serve as the State's liaison to national and state
17 organizations that support its mission.

1 The establishment of this commission replaces the
2 commission created by Executive Order 94-01."

3 SECTION 2. Section 90D-3, Hawaii Revised Statutes, is
4 amended by amending subsection (a) to read as follows:

5 "(a) [~~Members~~] Except as otherwise provided, members of
6 the commission shall be appointed by the governor on a
7 bipartisan basis subject to section 26-34. The commission shall
8 consist of not fewer than fifteen and not more than twenty-five
9 members. Not more than fifty per cent of the commission plus
10 one member may be from the same political party. To the extent
11 possible, the commission shall be balanced according to race,
12 ethnicity, age, disability, and gender characteristics. All
13 appointments shall be for three-year terms. Members shall not
14 serve more than two consecutive terms. The commission shall
15 include:

- 16 (1) An individual with expertise in the educational,
17 training, and developmental needs of youths,
18 particularly disadvantaged youths;
- 19 (2) An individual with experience in promoting the
20 involvement of older adults in service and
21 volunteerism;
- 22 (3) A representative of community-based agencies or
23 community-based organizations within the State;

- 1 (4) The superintendent of education, or a designee;
- 2 (5) A representative of [~~county governments;~~] the city and
- 3 county of Honolulu designated by the mayor of the city
- 4 and county of Honolulu;
- 5 (6) A representative of the county of Hawaii designated by
- 6 the mayor of the county of Hawaii;
- 7 (7) A representative of the county of Maui designated by
- 8 the mayor of the county of Maui;
- 9 (8) A representative of the county of Kauai designated by
- 10 the mayor of the county of Kauai;
- 11 ~~(6)~~ (9) A representative of local labor organizations in
- 12 the State;
- 13 ~~(7)~~ (10) A representative of business;
- 14 ~~(8)~~ (11) An individual between the ages of sixteen and
- 15 twenty-five who is a participant or supervisor in a
- 16 volunteer or service program; [~~and~~]
- 17 ~~(9)~~ (12) A representative of a national service program
- 18 described in Title 42 United States Code section
- 19 ~~[12572(a),]~~ 12572(a), (b), or (c), as amended, as a
- 20 nonvoting, ex officio member~~[-]~~; and
- 21 (13) A representative of the volunteer sector."

22 SECTION 3. Section 90D-5, Hawaii Revised Statutes, is

23 amended to read as follows:

1 "~~[f]§90D-5 [f]~~ **Meetings.** The commission shall meet at
2 least ~~[quarterly. Failure to attend at least seventy-five per~~
3 ~~cent of called meetings in any calendar year shall result in~~
4 ~~removal from the commission.]~~ twice annually. A quorum shall
5 consist of a ~~[simple]~~ majority of voting members. All meetings
6 of the commission shall be conducted subject to chapter 92."

7 SECTION 4. Statutory material to be repealed is bracketed
8 and stricken. New statutory material is underscored.

9 SECTION 5. This Act, upon its approval, shall take effect
10 on July 1, 2022.

Report Title:

Department of Business, Economic Development, and Tourism;
Commission for National and Community Service

Description:

Transfers for administrative purposes only the Commission for National and Community Service from the University of Hawaii to the Department of Business, Economic Development, and Tourism. Adds a representative from each county mayor's office to the commission and a representative of the volunteer sector. Also changes meeting requirements from quarterly to twice annually.

JUSTIFICATION SHEET

DEPARTMENT: University of Hawaii

TITLE: A BILL FOR AN ACT RELATING TO THE COMMISSION FOR NATIONAL AND COMMUNITY SERVICE.

PURPOSE: Transfer for administrative purposes only the Commission for National and Community Service (Commission) from the University of Hawaii (UH) to the Department of Business, Economic Development, and Tourism (DBEDT); add a representative from each county mayor's office to the Commission and a representative of the volunteer sector; and amend meeting requirements from quarterly to twice annually.

MEANS: Amend sections 90D-2, 90D-3(a), and 90D-5, Hawaii Revised Statutes.

JUSTIFICATION: The Commission is currently under the University of Hawaii for administrative purposes only. Transferring the Commission from UH to DBEDT would be more appropriate administratively as DBEDT manages a variety of statewide economic and community initiatives. This bill would also add a representative from each county mayor's office to the Commission. In doing so, it will help to increase geographic diversity on the Commission and encourage more program participation throughout the state. As currently codified in statute, the Commission is to meet quarterly, but most of the substantive work of the Commission can be done in two meetings a year. If the Commission finds it necessary, additional meetings can be called.
