A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE SEVENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The seventh senatorial district encompasses the
2 islands of Moloka'i, Lāna'i, and Kaho'olawe, as well as Hāna, east
3 and upcountry Maui all the way to Kahului Airport. This is one
4 of the "canoe" districts; as such, each island area has vastly
5 different capital improvement project needs.

6 The purpose of this Act is to appropriate funds for capital
7 improvement projects in the seventh senatorial district.

8 SECTION 2. The director of finance is authorized to issue
9 general obligation bonds in the sum of \$79,548,700 or so much
10 thereof as may be necessary, and the same sum or so much thereof
11 as may be necessary is appropriated for fiscal year 2021-2022
12 for the purpose of capital improvement projects for the seventh
13 senatorial district, as follows:

- 14 1. Upcountry Maui Watershed
- 15 A. Plans, land, design, and
- 16 construction for improvements.

5 SECTION 3. The appropriations made for the capital
6 improvement projects authorized by this Act shall not lapse at
7 the end of the fiscal year for which the appropriations are
8 made; provided that all moneys from the appropriations that are
9 unencumbered as of June 30, 2024, shall lapse as of that date.

10 SECTION 4. The sums appropriated for the respective
11 capital improvement projects set forth in section 2 shall be
12 expended for the purposes of this Act as follows:

- 13 (1) The sums appropriated in items 1 to 5 shall be
14 expended by the department of land and natural
15 resources; and
- 16 (2) The sums appropriated in items 6 to 13 shall be
17 expended by the department of transportation; and
- 18 (3) The sums appropriated in items 14 to 15 shall be
19 expended by the department of health; and
- 20 (4) The sum appropriated in item 16 shall be expended by
21 the department of labor and industrial relations.



1 SECTION 5. This Act shall take effect on July 1, 2021.
