A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

13 SECTION 26. The fiscal year 2021-2022 appropriations under
14 this Act shall not lapse until the end of fiscal biennium 2021-
15 2023; provided that funds appropriated or authorized by this Act
16 that are not expended or encumbered by June 30, 2023, shall
17 lapse as of that date.

18 SECTION 27. This Act shall take effect on July 1, 2021.
