A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the federal
2	Department of Transportation intends to modernize its planning
3	and projects throughout the country by implementing two primary
4	goals, which include equity for all communities and addressing
5	climate change. The State of Hawaii has adopted similar goals
6	including reaching one hundred per cent clean energy and a
7	carbon negative economy by 2045.
8	The legislature further finds that in addition to
9	modernizing transportation by meeting these new state and
10	national goals in Hawaii's transportation planning and projects,
11	the way people use transportation in Hawaii has already begun to
12	rapidly change. For example, the number of Hawaii's youngest
13	licensed drivers, between the ages of fifteen and nineteen, has
14	plummeted nearly forty per cent in the last twenty-five years.
15	In addition to the generational shift away from cars, today many
16	drivers are switching from traditional gas cars to modern

- 1 electric vehicles, with sales increasing exponentially between
- 2 twenty and thirty per cent each year.
- 3 These changes are due, in part, to increased cost of living
- 4 and transportation expenses. For instance, buying or leasing a
- 5 car also includes other fees such as monthly auto insurance
- 6 premiums, fuel costs, and vehicle maintenance expenses, which
- 7 makes owning a car the most expensive form of transportation. A
- 8 recent report by AAA insurance company noted that these
- 9 additional expenses, on average, cost each car owner an
- 10 additional \$8,849 per year. However, utilizing public
- 11 transportation, biking, walking, and living close to work can
- 12 significantly reduce the cost of transportation and measurably
- 13 improve public health. Yet, in those communities in which there
- 14 is no infrastructure available to travel except by car,
- 15 residents are forced to pay a higher cost of living expenses and
- 16 enjoy fewer options to improve their quality of life.
- In Hawaii and around the country, inequitable investments
- 18 into infrastructure have exacerbated costs and health
- 19 disparities among different communities. Low-income areas
- 20 typically have less access to bike lanes, sidewalks, and safe
- 21 forms of cheaper transportation. This leaves low-income

1 households in auto-centric communities more likely to fall into 2 poverty, which is exacerbated in rural areas with no access to 3 transit and longer distances between destinations. One direct 4 outcome of this problem has resulted in drivers striking and 5 killing people who walk in low-income neighborhoods at a much 6 higher rate than in high income neighborhoods due to a lack of 7 safe infrastructure. 8 The legislature further finds that while Hawaii's progress 9 to one hundred per cent clean energy by 2045 has reduced 10 emissions and the cost of electricity for local residents by 11 decreasing a reliance on costly imported fossil fuels, vehicles 12 now account for nearly two-thirds of Hawaii's greenhouse gas 13 emissions and increasing cost to taxpayers. Today, clean 14 electric vehicles are already less expensive to operate and 15 maintain than traditional gas cars, and are now similar in 16 price. Modernizing ground transportation to support the switch 17 to electric vehicles will not only reduce long-term costs for 18 local commuters, but will also help meet Hawaii's goals to 19 eliminate fossil fuels in ground transportation and sequester 20 more greenhouse gasses than the State emits by 2045.

Additionally, rethinking the way Hawaii builds ground 1 2 transportation infrastructure will not only reduce the cost of 3 living and improve the quality of life for local residents, it 4 will also serve as an economic stimulus. Greenways, sidewalks, 5 and bike facilities have the largest return on their investment, 6 stimulating construction and economic benefits by approximately 7 seventeen to one, because of the varied nature of the work. 8 Simply adding lanes to roads or bridges only produces benefits 9 of between nine and twelve, to one. Streets with additional 10 access to cheaper forms of transportation, such as bike lanes, 11 have also been reliably shown to improve visitors and revenues 12 at area businesses by as much as forty percent. 13 The legislature further finds that over the last century, 14 Hawaii's ground transportation was built as a car-centric 15 system, with little attention to alternatives, which has raised 16 the cost of living in the islands, impacted quality of life, and 17 resulted in some of the highest transportation-related fatality 18 rates in the nation. Merely adding lanes to reduce traffic does 19 not address Hawaii's most pressing traffic, safety, health, and 20 other issues. In fact, it can often make them worse. Studies 21 show the traffic benefits of spending tens of millions of

- 1 dollars adding lanes to accommodate more cars are often
- 2 eliminated in just a few years by additional cars incentivized
- 3 to take up that space. Those funds could have had a more
- 4 significant and longer-lasting benefit reducing traffic and
- 5 addressing other issues by building alternative options for
- 6 people to commute by improving public transportation, biking, or
- 7 walking, especially for those who can least afford it.
- 8 Accordingly, the purpose of this Act is to modernize
- 9 Hawaii's ground transportation infrastructure by providing
- 10 additional metrics, considerations, and assistance to the
- 11 department of transportation in order to move Hawaii forward
- 12 into the twenty-first century by:
- 13 (1) Reducing transportation costs to local residents;
- 14 (2) Minimizing injuries and fatalities;
- 15 (3) Improving public health and quality of life; and
- 16 (4) Addressing greenhouse gas emissions.
- 17 SECTION 2. Chapter 264, Hawaii Revised Statutes, is
- 18 amended by adding four new sections to be appropriately
- 19 designated and to read as follows:
- 20 "§264- Ground transportation facilities. (a) There
- 21 shall be planned for and established a contiguous network of

- 1 motor vehicle highways connecting communities throughout each
- 2 island, in which intersections with other modes of
- 3 transportation shall be minimized, in which a priority and
- 4 preference shall be given for access by public mass
- 5 transportation.
- 6 (b) There shall be planned for and established a
- 7 contiguous network of bicycle and electric bicycle highways
- 8 connecting communities throughout each island, in which
- 9 intersections with other modes of transportation shall be
- 10 minimized, which shall be separated and protected from vehicular
- 11 traffic by physical or natural barriers or by meaningful
- 12 distance or elevation.
- (c) There shall be planned for and established a
- 14 contiguous network of pedestrian highways connecting communities
- 15 throughout each island, in which intersections with other modes
- 16 of transportation shall be minimized, which shall be separated
- 17 and protected from vehicular and bicycle traffic by physical or
- 18 natural barriers, or by meaningful distance or elevation.
- 19 (d) Within each community or communities, the department
- 20 shall ensure each county plans for and establishes, and the
- 21 department plans for and establishes any state portions of:

1	(1)	A contiguous bicycle and pedestrian network connecting
2		all public schools and libraries in each school
3		complex to one another, and to its respective state
4		and county transportation infrastructure, in which
5		intersections with other modes of transportation shall
6		be minimized, which shall be separated and protected
7		from vehicular traffic by physical or natural
8		barriers, or by meaningful distance or elevation;
9	(2)	A contiguous bicycle and pedestrian network connecting
10		commercial business and shopping hubs to residential
11		areas, and to its respective state and county
12		transportation infrastructure, in which intersections
13		with other modes of transportation shall be minimized,
14		which shall be separated and protected from vehicular
15		traffic by physical or natural barriers, or by
16		meaningful distance or elevation; and
17	(3)	Pedestrian exercise and active health pathways of
18		meaningful length in which intersections with other
19		modes of transportation shall be minimized, which
20		shall be separated and protected from vehicular
21		traffic by physical or natural barriers, or by

1		meaningful distance or elevation, which are easily
2		accessible to residential and high density communities
3		where appropriate.
4	<u>§264</u>	- Project goals. (a) When planning, designing, and
5	implement	ing ground transportation infrastructure, the
6	departmen	t shall consider and pursue goals in each project to:
7	(1)	Assess and maximize total throughput of people across
8		all modes of transportation;
9	(2)	Meet complete streets goals as defined in section
10		264-20.5;
11	(3)	Reduce vehicle miles traveled;
12	(4)	Provide capacity to meet future model share goals
13		established by the ground transportation modernization
14		commission;
15	(5)	Provide equity for all communities and users;
16	(6)	Improve safety and achieve vision zero goals defined
17		<u>in section 286-75;</u>
18	<u>(7)</u>	Reduce user cost of transportation;
19	(8)	<pre>Improve public health;</pre>
20	(9)	Reduce carbon emissions and greenhouse gasses to meet
21		state climate and zero emissions clean economy goals

1		defined in section 269-92 and zero emissions clean
2		economy by 2045 as defined in section 225P-5;
3	(10)	Reduce urban temperatures by incorporating tree canopy
4		and foliage over hardened surfaces; and
5	(11)	Beautify public infrastructure.
6	<u>§264</u>	Ground transportation modernization commission.
7	(a) There	e is established within the department of
8	transport	ation for administrative purposes only, a ground
9	transport	ation modernization commission consisting of members
10	who shall	be appointed as follows:
11	(1)	The administrator of the office of energy;
12	(2)	The director of the department of health or designee;
13	(3)	A state sustainability coordinator;
14	(4)	The chair of the senate committee with jurisdiction
15		over transportation;
16	(5)	The chair of the house committee with jurisdiction
17		over transportation;
18	<u>(6)</u>	The director of the department of education or
19		designee;
20	(7)	The director of state charter schools or designee;
21	(8)	The director of state libraries or designee;



1	<u>(9)</u>	The chair of the University of Hawaii's department of
2		urban and regional planning or designee;
3	(10)	A representative of the state climate commission or
4		designee;
5	(11)	A representative of a bicycle advocacy organization;
6	(12)	A representative of a pedestrian advocacy
7		organization;
8	(13)	A representative of public health advocacy
9		organization; and
10	(14)	A mayor of each county or designee.
11	The	commission members shall annually elect one of the
12	members t	o serve as chairperson of the commission. The
13	commissio	n members may approve other members it finds
14	appropria	te.
15	(b)	The ground transportation modernization commission
16	shall:	
17	(1)	Provide independent assistance and oversight to the
18		department to help modernize ground transportation;
19	(2)	Establish future mode share targets and benchmarks for
20		2030 2040 and 2050 that align and achieve the

1		transportation, safety, economic, equitable, public
2		health, and climate goals of the state of Hawaii; and
3	(3)	Review annual progress toward these goals and provide
4		recommendations and guidance to the department and
5		legislature in assessing, meeting, and achieving the
6		goals of this measure.
7	<u>(c)</u>	The commission shall meet no less than quarterly and
8	shall pro	vide an annual report to the legislature on January 1st
9	of each y	ear beginning in 2022. The annual report shall include
10	a full an	d complete statement with any findings and
11	recommend	ations, including any proposed legislation that the
12	commissio	n deems necessary or desirable.
13	<u>§264</u>	- Highways, ground transportation, generally. The
14	departmen	t shall provide for a safe, accessible, equitable,
15	fully mul	timodal, and sustainable system of ground connections
16	that ensu	res the accessibility of people and goods, improves
17	economic	vitality, public health, livability, and quality of
18	<u>life.</u> "
