A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that there is a need to
3	modernize state government to reflect the current generation of
4	Hawaii residents, as recent studies have shown a lack of public
5	support for government in the State. Furthermore, the current
6	structure of government presents challenges to effective and
7	efficient governing at all levels. The legislature also finds
8	that the needs of society have changed drastically, with greater
9	emphasis on modernization, transparency, and accountability, and
10	that these needs should be reflected in the functions and
11	services provided by state government.
12	The purpose of this part is to establish the state
13	government realignment commission to periodically review the
14	state executive branch's departments, divisions, and agencies,
15	including functions and services, and submit its findings and
16	recommendations to the legislature.

1	SECTION 2. The Hawaii Revised Statutes is amended by
2	adding a new chapter to title 4 to be appropriately designated
3	and to read as follows:
4	"CHAPTER
5	STATE GOVERNMENT REALIGNMENT COMMISSION
6	§ -1 Establishment of the commission. (a) There is
7	established a state government realignment commission,
8	hereinafter called the commission, which shall be placed within
9	the department of accounting and general services for
10	administrative purposes. The commission shall consist of
11	seven members. Three members shall be appointed by the
12	governor, two members by the president of the senate, and
13	two members by the speaker of the house of representatives. All
14	members appointed by the governor shall be subject to the advice
15	and consent of the senate. The commission shall elect its
16	chairperson from among its members.
17	(b) The members of the commission shall receive no
18	compensation for their services but shall be reimbursed for

(c) To perform its duties, the commission may engageemployees without regard to chapter 76 and enter into contracts

actual expenses incurred in the performance of their duties.

- 1 with consultants. Departments of the state government shall
- 2 make available to the commission any data and facilities that
- 3 are necessary for the commission to perform its duties.
- 4 § -2 Term. Members of the commission shall be appointed
- 5 and confirmed on or before July 1, 2022, and new members of the
- 6 commission shall be appointed and confirmed on or before July 1
- 7 every ten years thereafter; provided that if any vacancy occurs
- 8 in the membership of a commission prior to the completion of its
- 9 duties or dissolution, there shall be appointed a replacement
- 10 member in accordance with section 26-34. The commission shall
- 11 meet as necessary to execute its duties. The commission shall
- 12 dissolve upon the adjournment sine die of the legislature to
- 13 which it submits the evaluation and recommendations required by
- 14 section -3.
- 15 § -3 Duties. The commission shall conduct a systematic
- 16 review of the state executive branch's departments, divisions,
- 17 and agencies, including functions and services, that uses
- 18 standards such as equity, efficiency, and modernization to
- 19 consolidate, expand, or reassign services. Thirty days prior to
- 20 the convening of the second regular session of the legislature
- 21 after the members of the commission have been appointed, the

- 1 commission shall submit to the legislature the findings of its
- 2 systemic review of the state executive branch and any
- 3 recommendations based on the findings; provided that the
- 4 legislature shall review and take into consideration the
- 5 commission's findings and recommendations."
- 6 PART II
- 7 SECTION 3. The legislature finds that broadband is the
- 8 critical infrastructure of the twenty-first century. The term
- 9 "broadband" has been generally defined as a data transmission
- 10 service that enables users, such as residents, schools,
- 11 businesses, and government, to access the Internet and use web
- 12 applications at particular speeds. From a practical standpoint,
- 13 broadband allows a student to connect to a remote classroom,
- 14 businesses to conduct secure financial transactions, and health
- 15 providers to serve patients without coming into a clinic or
- 16 hospital.
- In March 2020, when the coronavirus disease 2019 (COVID-19)
- 18 pandemic required all residents to shelter in place, broadband
- 19 became fundamental to everyday life. The public and private
- 20 sectors immediately shifted to remote work, schools transitioned
- 21 to distance learning, and many services were available only

- 1 online. Evolving solutions to meet the COVID-19 crisis and
- 2 communication about those solutions were posted on social media
- 3 and various websites. During the evolution of the pandemic, the
- 4 digital divide between those with broadband access and those
- 5 without became painfully evident.
- 6 The legislature further finds that broadband is a public
- 7 sector priority and access to broadband should not be limited by
- 8 geographical location or ability to pay.
- 9 The purpose of this part is to significantly increase
- 10 access to broadband for the most vulnerable populations in the
- 11 State by appropriating funds for various broadband
- 12 infrastructure installation or expansion.
- 13 SECTION 4. There is appropriated out of the funds received
- 14 by the State from the American Rescue Plan Act, Public
- 15 Law 117-2, the sum of \$ or so much thereof as may be
- 16 necessary for fiscal year 2021-2022 and the same sum or so much
- 17 thereof as may be necessary for fiscal year 2022-2023 for:
- 18 (1) The purchase of secure and reliable high-speed
- 19 broadband through fixed fiber or copper connections
- and high-speed wireless, such as wi-fi;
- 21 (2) Endpoint device availability and management;

- 1 (3) Support and management of technical issues;
- 2 (4) Network management of user needs; and
- 3 (5) Changing network requirements;
- 4 provided that priority shall be given to rural and underserved
- 5 communities, including state public housing and geographic areas
- 6 with high concentration of low-income students served by Title I
- 7 recipients.
- 8 The sums appropriated shall be expended by the department
- 9 of accounting and general services for the purposes of this
- 10 part.
- 11 SECTION 5. There is appropriated out of the funds received
- 12 by the State from the American Rescue Plan Act, Public
- 13 Law 117-2, the sum of \$ or so much thereof as may be
- 14 necessary for fiscal year 2021-2022 and the same sum or so much
- 15 thereof as may be necessary for fiscal year 2022-2023 for the
- 16 purchase and installation of broadband infrastructure to enhance
- 17 and upgrade broadband and internet connectivity for state
- 18 buildings, including libraries.
- 19 The sums appropriated shall be expended by the department
- 20 of accounting and general services for the purposes of this
- **21** part.

1	SECTION 6. There is appropriated out of the funds received		
2	by the State from the American Rescue Plan Act, Public		
3	Law 117-2, the sum of \$ or so much thereof as may be		
4	necessary for fiscal year 2021-2022 and the same sum or so much		
5	thereof as may be necessary for fiscal year 2022-2023 for:		
6	(1) Extension of fiber to every department of education		
7	classroom building's wiring room, as needed, in order		
8	to provide fiber interconnection to every classroom		
9	building resulting in better network performance and		
10	management for each classroom; and		
11	(2) Enhancement and upgrade of cabling from the wiring		
12	room to every classroom, for every department of		
13	education classroom building, as needed, to support		
14	better connectivity and performance for student		
15	devices.		
16	The sums appropriated shall be expended by the department		
17	of accounting and general services for the purposes of this		
18	part.		
19	SECTION 7. The department of accounting and general		
20	services and department of transportation shall submit an annual		
21	report to the legislature by December 1, regarding		

1	implementation of this part and any other broadband projects		
2	implement	ed by the departments, including but not limited to:	
3	(1)	The status of procurement of broadband services and	
4		equipment;	
5	(2)	Total number and prioritization of broadband delivery	
6		sites statewide and by county;	
7	(3)	Estimated number of households served statewide and by	
8		county; and	
9	(4)	Future funding and any proposed legislation, if any.	
10		PART III	
11	SECT	ION 8. This Act shall take effect on July 1, 2112.

State Government Realignment Commission; Departments; Divisions; Agencies; Broadband Infrastructure; American Rescue Plan Act; Appropriation

Description:

Establishes a state government realignment commission to periodically review the state executive branch's departments, divisions, and agencies, including functions and services, and submit its findings and recommendations to the legislature. Appropriates American Rescue Plan Act funds for various broadband infrastructure installation and updates throughout the State and requires an annual report regarding these projects. Effective 7/1/2112. (HD2)
