A BILL FOR AN ACT

RELATING TO SPECIAL PURPOSE REVENUE BONDS TO ASSIST HOUSE OF ALOHA ENTERPRISES LLC.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds and declares that the
- 2 issuance of special purpose revenue bonds under this Act is in
- 3 the public interest and for the public health, safety, and
- 4 general welfare.
- 5 SECTION 2. Pursuant to part IV, chapter 39A, Hawaii
- 6 Revised Statutes, the department of budget and finance, with the
- 7 approval of the governor, is authorized to issue special purpose
- 8 revenue bonds in a total amount not to exceed \$, in
- 9 one or more series, for the purpose of assisting House of Aloha
- 10 Enterprises LLC, a Hawaii limited liability company, with
- 11 planning, designing, constructing, and equipping facilities for
- 12 the purpose of creating business in Hawaii for the
- 13 manufacturing, processing, and distribution of products such as
- 14 but not limited to the production of value-added agricultural,
- 15 advanced materials, sustainable, and fine art products. The
- 16 legislature hereby finds and determines that the planning,

- 1 designing, constructing, and equipping of facilities in Hawaii
- 2 for the manufacturing and processing of products such as the
- 3 production of value-added agricultural products constitute a
- 4 project as defined in part IV, chapter 39A, Hawaii Revised
- 5 Statutes, and the financing thereof is assistance to a
- 6 processing enterprise.
- 7 SECTION 3. The special purpose revenue bonds and the
- 8 refunding special purpose revenue bonds issued under this Act
- 9 shall be issued pursuant to part IV, chapter 39A, Hawaii Revised
- 10 Statutes, relating to the power to issue special purpose revenue
- 11 bonds to assist processing enterprises.
- 12 SECTION 4. The department of budget and finance is
- 13 authorized, from time to time, including times subsequent to
- 14 June 30, 2026, to issue special purpose revenue bonds in
- 15 whatever principal amounts the department shall determine to be
- 16 necessary to refund the special purpose revenue bonds authorized
- in section 2 and to refund special purpose revenue bonds
- 18 authorized in this section, regardless of whether the
- 19 outstanding special purpose revenue bonds or refunding special
- 20 purpose revenue bonds have matured or are the subject of
- 21 redemption or whether the refunding special purpose revenue

- 1 bonds shall be bonds for the multi-project programs described in
- 2 section 2. In making this determination, the department shall
- 3 comply with federal law relating to the exemption from federal
- 4 income taxation of the interest on bonds of the nature
- 5 authorized by this section.
- 6 SECTION 5. The authorization to issue special purpose
- 7 revenue bonds under this Act shall lapse on June 30, 2026.
- 8 SECTION 6. This Act shall take effect on July 1, 2050.
