# A BILL FOR AN ACT

RELATING TO HAWAIIAN AFFAIRS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Chapter 329D-2, Hawaii Revised Statutes, is  
2 amended by amending subsections (d) and (e) to read as follows:  
3           "(d) The department shall issue eight dispensary licenses  
4 statewide; provided that three dispensary licenses shall be  
5 issued for the city and county of Honolulu, two dispensary  
6 licenses each shall be issued for the county of Hawaii and the  
7 county of Maui, and one dispensary license shall be issued for  
8 the county of Kauai; provided further that no dispensary license  
9 shall be issued for the county of Kalawao.  
10           Notwithstanding this subsection, the department of Hawaiian  
11 home lands may operate            medical cannabis dispensaries.  
12 Dispensaries as overseen by the department of Hawaiian home  
13 lands shall not be considered toward the number of dispensaries  
14 issued statewide.  
15           (e) No person may be granted a dispensary license in more  
16 than one county[-]; provided that dispensaries as overseen by

1 the department of Hawaiian home lands shall not be considered  
2 toward the number of dispensaries issued per county."

3 SECTION 2. Section 219.1, Hawaiian Homes Commission Act,  
4 1920, as amended, is amended to read as follows:

5 "(b) Notwithstanding any law to the contrary, the  
6 department either alone or together with any other governmental  
7 agency, may:

8 (1) Form an insurance company, association (nonprofit or  
9 otherwise), pool, or trust;

10 (2) Acquire an existing insurance company;

11 (3) Enter into arrangements with one or more insurance  
12 companies; [~~or~~]

13 (4) Operate medical cannabis dispensaries pursuant to  
14 chapter 329D; or

15 [~~(4)~~] (5) Undertake any combination of the foregoing; upon  
16 such terms and conditions and for such periods, as the  
17 commission shall approve, to provide homeowner  
18 protection, including hurricane coverage, for lessees  
19 participating in such undertaking. Such undertaking  
20 shall be subject to the provisions of chapter 431P,



1 including but not limited to section 431P-10(b), and  
2 chapter 431."

3 SECTION 3. The provisions of the amendments made by this  
4 Act to the Hawaiian Homes Commission Act, 1920, as amended, are  
5 declared to be severable, and if any section, sentence, clause,  
6 or phrase, or the application thereof to any person or  
7 circumstances is held ineffective because there is a requirement  
8 of having the consent of the United States to take effect, then  
9 that portion only shall take effect upon the granting of consent  
10 by the United States and effectiveness of the remainder of these  
11 amendments or the application thereof shall not be affected.

12 SECTION 4. Statutory material to be repealed is bracketed  
13 and stricken. New statutory material is underscored.

14 SECTION 5. This Act shall take effect upon its approval.
