A BILL FOR AN ACT

RELATING TO FARM TO SCHOOL PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that building farm to
- school connections can improve student access to healthy, local 2
- foods, provide numerous public health benefits, and contribute 3
- to the local agricultural industry. The National Farm to School
- Network reports that increasing local food procurement in 5
- schools provides economic benefits to school districts by
- increasing student and teacher meal participation and decreasing 7
- school meal program costs. 8
- The legislature also finds that local food procurement 9
- provides economic benefits to local food systems by providing a 10
- 11 long-term revenue stream for farmers and other food producers,
- promoting market diversification, and increasing income and 12
- economic growth opportunities for individual farmers. The 2008 13
- 14 Farm Bill directed the Secretary of Agriculture to encourage
- 15 schools to purchase unprocessed locally grown and locally raised
- products "to the maximum extent practicable and appropriate." 16
- 17 The Secretary was also instructed to allow child nutrition



- 1 program operators to use a "geographic preference" when
- procuring unprocessed locally grown and locally raised
- 3 agricultural products.
- 4 The purpose of this Act is to create a limited procurement
- 5 exemption system for the purchase of goods and services by the
- 6 department of education related to the administration of food
- 7 programs at public schools that will incorporate a geographic
- 8 preference for unprocessed locally grown and locally raised food
- 9 products. This Act will thereby facilitate the increase of
- 10 locally grown and locally raised food products from Hawaii
- 11 farmers, ranchers, and food producers and allow school complexes
- 12 to regionalize their menus.
- SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "§302A- Food program; procurement; geographic
- 17 preference; exemption. (a) The department shall establish
- 18 rules pursuant to chapter 91 for the procurement of goods and
- 19 services related to the administration of food programs at
- 20 public schools that incorporate a geographic preference for

3	(b)	The rules shall be in accordance with federal guidance
4	on geogra	phic preference pursuant to the final rule published on
5	April 22,	2011, 76 Federal Register 22603, et seq.
6	<u>(c)</u>	The rules shall also incorporate requirements for:
7	(1)	Maintaining internal policies and procedures for the
8		timely and efficient procurement of goods and
9		services, including post-award contract management and
10		oversight procedures, that are consistent with the
11		goals of public accountability and public procurement
12		practices;
13	(2)	Posting the following information on the department's
14		website:
15		(A) Procurement policies;
16		(B) All solicitations, including any bid openings and
17		additional solicitation documents; and
18		(C) All contracts awarded by the department for goods
19		and services related to the administration of
20		food programs at public schools that incorporate
21		a geographic preference for unprocessed locally

1		grown and locally raised agricultural products,
2		including contracts involving realizations and
3		<pre>in-kind benefits;</pre>
4	(3)	Prohibiting contracts involving cost plus percentage
5		of cost pricing calculations;
6	(4)	Considering quality, delivery, best value,
7		sustainability, nutritional value, and past
8		performance when determining the most advantageous
9		proposal;
10	(5)	Prohibiting artificial division or parceling that
11		would avoid competitive bidding or competitive
12		proposals; and
13	(6)	Implementing a dispute resolution process for
14		procurement award and post-award contract actions.
15	(d)	All contracts made for the procurement of goods and
16	services	pursuant to rules adopted under this section shall
17	<u>include a</u>	period of performance.
18	(e)	Except for section 103D-1002, all contracts made for
19	the procu	rement of goods and services pursuant to rules adopted
20	under thi	s section shall be exempt from chapter 103D.

l	(f) Nothing in this section shall be construed to permit
2	the awarding of contracts based on geographic preference to
}	supersede the competitive bidding process."

Report Title:

Public School Food Programs; Farm to School; Department of Education; Procurement; Geographic Preference; Locally Grown Food; Exemption

Description:

Requires the department of education to establish rules for the procurement of goods and services related to the administration of food programs at public schools that incorporate a geographic preference for unprocessed locally grown and locally raised food products. Except for the provision relating to Hawaii products, exempts the department's food program from the Hawaii public procurement code.
