SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO PROVIDE A SCHOOL RESOURCE OFFICER OR REGISTERED GUARD AT EACH ELEMENTARY SCHOOL AND STATE PREKINDERGARTEN PROGRAM.

WHEREAS, in March 2018 at Kipapa Elementary School, a boy 1 reported that a man approached him in a school restroom and 2 tried to grab his hand; and 3 4 WHEREAS, on December 12, 2019, a manhunt in Waipahu 5 prompted officials at Waipahu High School and August Ahrens 6 Elementary School to place those schools on lockdown; and 7 8 WHEREAS, on February 27, 2020, following a report of a man 9 armed with a gun in Ewa Beach, Ilima Intermediate School, 10 Pohakea Elementary School, Kaimiloa Elementary School, and 11 Campbell High School initiated a lockdown; and 12 13 WHEREAS, some elementary school students may not be old 14 enough to properly assess potential dangers and act accordingly; 15 and 16 17 WHEREAS, posting dedicated security personnel at elementary 18 schools and public facilities that provide prekindergarten care 19 will help to deter the presence of individuals who do not belong 20 on school campuses, identify potentially dangerous situations, 21 and ensure that children are protected and can learn in a safe 22 environment; now, therefore, 23 24 BE IT RESOLVED by the Senate of the Thirty-first 25 Legislature of the State of Hawaii, Regular Session of 2021, the 26 House of Representatives concurring, that the Department of 27 Education is urged to provide a school resource officer or guard 28 registered pursuant to Chapter 463, Hawaii Revised Statutes, at 29 each elementary school and state prekindergarten program during 30 hours when students are expected to be on campus; and 31 32

1 BE IT FURTHER RESOLVED that the Department of Education is urged to provide multiple school resource officers or registered 2 guards at larger elementary schools and prekindergarten 3 4 programs; and 5 BE IT FURTHER RESOLVED that, if necessary, the Department 6 of Education is urged to seek federal grants and county funding 7 for the cost of providing school resource officers or registered 8 quards; and 9 10 BE IT FURTHER RESOLVED that certified copies of this 11 Concurrent Resolution be transmitted to the Superintendent of 12 Education, Chairperson of the Board of Education, and Mayor of 13 each county. 14 15 16 OFFERED BY: Kut Ferlo 17
