# SENATE RESOLUTION

URGING THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT TO  
ESTABLISH A NEW SERVICE CLASS FOR PROJECT MANAGERS UNDER  
COLLECTIVE BARGAINING UNIT 13.

1 WHEREAS, the position of project manager is not included  
2 under an existing civil servant class or series of government  
3 positions; and

4  
5 WHEREAS, during 2020, the Department of Human Resources  
6 Development worked with the Department of Accounting and General  
7 Services, Department of Hawaiian Home Lands, Department of Land  
8 and Natural Resources, and Department of Transportation to  
9 develop an agreed-upon description of a project manager  
10 position; and

11  
12 WHEREAS, no official actions were taken to create a project  
13 manager civil servant class or series; and

14  
15 WHEREAS, the agreed upon salary range of the civil servant  
16 class of project manager would follow the salary range for  
17 collective bargaining unit 13 (BU13); and

18  
19 WHEREAS, the salary range for project managers differs from  
20 that for Engineers and Architects, whose positions are normally  
21 two salary ranges higher than those normally attributed to  
22 members of BU13; and

23  
24 WHEREAS, engineering construction projects are managed by  
25 either an engineer or architect; and

26  
27 WHEREAS, this pay discrepancy would result in project  
28 managers being paid less than those they were managing; and

30 WHEREAS, departments that need a project manager position  
31 currently use a civil servant in the General Professional  
32 series, which is a generic series for professional work  
33 characteristics of BU13, as there is no civil service position  
34 class established for project managers; now, therefore,



1 BE IT RESOLVED by the Senate of the Thirty-first  
2 Legislature of the State of Hawaii, Regular Session of 2021,  
3 that the Department of Human Resources Development is requested  
4 to establish a new civil service class for project managers  
5 under BU13; and

7 BE IT FURTHER RESOLVED that the new civil service class use  
8 the general project manager position description agreed upon by  
9 the Department of Human Resources Development, Department of  
10 Accounting and General Services, Department of Hawaiian Home  
11 Lands, Department of Land and Natural Resources, and Department  
12 of Transportation; and

14 BE IT FURTHER RESOLVED that certified copies of this  
15 Resolution be transmitted to the Governor, Director of Human  
16 Resources Development, Comptroller, Chairperson of the Hawaiian  
17 Homes Commission, Chairperson of the Board of Land and Natural  
18 Resources, and Director of Transportation.
