No. 224, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE STATE HEALTH PLANNING AND
DEVELOPMENT AGENCY,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Change the administration of the State Health Planning and Development Special Fund and divert excess monies in the State Health Planning and Development Special Fund at the end of each fiscal year to the general fund;
- (2) Amend certain provisions for the certificate of need process; and
- (3) Appropriate funds for permanent positions within the State Health Planning and Development Agency.


