Your Committee on Finance, to which was referred H.B. No. 306, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Amend the definitions of "preceptor" and "volunteerbased supervised clinical training rotation" to improve accessibility for providers to receive income tax credits for acting as preceptors; and
- (2) Revise the membership of the Preceptor Credit Assurance Committee to include the Director of Health.

Your Committee received testimony in support of this measure from the Department of Taxation, University of Hawai'i System, Hawai'i Primary Care Association, The Queen's Health Systems, Hawaii State Rural Health Association, Hilo Medical Center Foundation, and four individuals.
