Your Committee finds that restorative justice is a values-based approach to community building, problem solving, and conflict resolution that builds and restores relationships, creates opportunities for dialogue, repairs harm, transforms conflict, and creates equitable learning environments in schools. Studies have shown that restorative justice practices can lead to reductions in problem behavior, improvements in school climate, and increases in student achievement, attendance, and graduation
