Your Committee on Culture, Arts, & International Affairs, to which was referred H.C.R. No. 182 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO CONDUCT A STUDY TO CREATE A STATUTORY DEFINITION OF CREATIVE WORKERS AND DEVELOP RECOMMENDATIONS ON HOW THE TRANSIENT ACCOMMODATIONS TAX MAY BE USED TO ASSIST CREATIVE WORKERS,"

begs leave to report as follows:

The purpose of this measure is to request the Legislative Reference Bureau to conduct a study to create a statutory definition of creative workers and develop recommendations on how the transient accommodations tax may be used to assist creative workers.

Your Committee received testimony in support of this measure from the Department of Business, Economic Development, and Tourism; Hawai'i Arts Alliance; Hawaii Youth Opera Chorus; and four individuals. Your Committee received comments on this measure from the Legislative Reference Bureau.

Your Committee finds that creative artists in the State have experienced significant economic hardship because of the COVID-19 pandemic's impact on Hawaii's economy, particularly the tourism industry. Your Committee further finds that in a June 2020 report by the Brookings Institute, Hawaii was ranked as one of the top

five states with a creative sector that has been affected by COVID-19 with job and revenue losses greater than the national average of 30.3 percent.
