"HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF TRANSPORTATION AND KAUAI DEPARTMENT OF PUBLIC WORKS TO CONDUCT A STUDY TO IDENTIFY AND RECOMMEND METHODS TO ALLEVIATE TRAFFIC CONGESTION AT CERTAIN INTERSECTIONS ALONG THE KAUMUALII HIGHWAY,"

begs leave to report as follows:

The purpose of this measure is to request the Department of Transportation and Department of Public Works of the County of Kauai to conduct a study to identify and recommend methods to alleviate traffic congestion at certain intersections along the Kaumualii Highway.

Your Committee received testimony in support of this measure from the Department of Transportation.

Your Committee finds that the Kaumualii Highway in the County of Kauai connects a number of communities in Kauai and acts as a link to access vital services for residents and visitors of Kauai. Your Committee further finds that fifty-two of the largest employers on Kauai are located in communities near the Kaumualii Highway, causing significant traffic congestion and disturbing the quality of life for many on Kauai. Your Committee believes the importance of Kaumualii Highway necessitates a collaborative
