RELATING TO THE WORKS OF ART SPECIAL FUND. HB 755

Status Excludes appropriations to the Department of Hawaiian Home Lands for the development of residential buildings from the general

requirement that 1% of capital improvement appropriations for state

buildings be transferred to the works of art special fund.

RELATING TO AMERICAN SIGN LANGUAGE. HB 840 Status Recognizes American Sign Language as a fully developed, CAI, JHA, CPC

autonomous, natural language with its own grammar, syntax,

vocabulary, and cultural heritage.

RELATING TO THE HAWAIIAN LANGUAGE. HB 1357

CAI, JHA, FIN

Status

Requires the governor, lieutenant governor, state legislators, and heads of principal departments to prominently display a Hawaiian translation of the name of their office or department at least once on the main page

of their official website and in the letterhead of their stationery.

HB 1358 RELATING TO HISTORIC PRESERVATION. CAI, JHA, FIN

CAI, FIN

Status

Defines "pre-contact historic property". Clarifies that the historic preservation program includes providing consultation to counties and public and private agencies involved in historic preservation and the development, publication, and distribution of materials about protections for burials, historic sites, and archaeological resources. Amends the composition and duties of the Hawaii historic places review board. Increases civil and administrative fines for certain violations of historic and preservation requirements and makes violators liable for costs associated with mitigation or restoration

measures.

HB 1164 **Status**

RELATING TO THE BERNICE PAUAHI BISHOP MUSEUM. Appropriates funds to support the Bernice Pauahi Bishop Museum,

including the hiring of necessary staff.

CAI, JHA, FIN RELATING TO THE FESTIVAL OF PACIFIC ARTS. HB 625

Extends the date on which the temporary commission on the thirteenth **Status**

festival of pacific arts shall cease to exist to August 31, 2025. Permits the commission members to discuss matters relating to official board business without regard to chapter 92, Hawaii Revised Statutes, to

enable them to perform their duties faithfully.

Recognizes La Ku'oko'a, Hawaiian Recognition Day, as an official Status

state holiday. Removes election day as an official state holiday.
