<u>SB 48</u> <u>Status &</u> <u>Testimony</u>	RELATING TO SEX TRAFFICKING. Includes coercion as a means of committing the offense of sex trafficking. Removes the criminal statute of limitations for sex trafficking and promoting prostitution. Designates solicitation of a minor for prostitution as a form of sex trafficking. Specifies that sex trafficking of a minor is a strict liability offense. Repeals the offense of solicitation of a minor for prostitution.	HMS, JDC
<u>SB 409</u> <u>Status &</u> <u>Testimony</u>	RELATING TO SEX TRAFFICKING. Amends section 712-1202, Hawaii Revised Statutes, to include coercion as a means of committing the offense of sex trafficking.	HMS, JDC
<u>SB 753</u> Status & Testimony	RELATING TO SEX TRAFFICKING. Provides that a prosecution for sex trafficking shall not be subject to a statute of limitations.	HMS, JDC
