Status & Establishes conditions and time limits for placing a child in room

confinement at a detention or shelter facility.

SB 391 RELATING TO EXPUNGEMENT. HMS, JDC

Status & Authorizes a court to expunge the records of a person for certain

Testimony offenses if they are substantially related to the person's

homeless status.

SB 410 RELATING TO ABUSE OF FAMILY OR HOUSEHOLD HMS, JDC

MEMBER.

Status & Adds abuse of a family or household member to those felonies

Testimony that qualify for repeat offender sentencing.

Decision Making to follow, if time permits.
