HB 175, HD1 (HSCR753) Status & Testimony	RELATING TO SEX TRAFFICKING. Amends section 712-1202, Hawaii Revised Statutes, to include coercion as a means of committing the offense of sex trafficking. (HD1)	HMS, JDC
HB 282, HD1 (HSCR826) Status & Testimony	RELATING TO MINORS. Expands the circumstances where a minor may consent to no cost emergency shelter and related services to include cases where the provider is coordinating with child welfare services. Effective 7/1/2060. (HD1)	HMS, JDC
HB 722, HD2 (HSCR698) Status & Testimony	RELATING TO HUMAN TRAFFICKING. Establishes a statewide program overseen by the department of the attorney general to provide services and assistance to commercially sexually exploited children and victims of human trafficking. Requires the children's justice program to coordinate the investigation and case management of child human trafficking cases, including cases involving the commercial sexual exploitation of children. HB 887, HD1 RELATING TO CRIME. HMS, JDC Creates a separate offense for those who provide anything of (HSCR756) value to engage in sexual conduct with another. Adds sex trafficking to offenses that can be prosecuted at any time. Status & Makes a person strictly liable for sex trafficking of a minor in **Testimony** terms of the victim's age. Changes the name of the crime of solicitation of a minor for prostitution to commercial sexual exploitation of a minor. Increases the grade of offense to a class B felony. Adds "anything of value" as a type of compensation for purposes of engaging in commercial sexual exploitation. Effective 7/1/3021. (HD1) HB 975, HD1 RELATING TO REPORTS OF CHILD ABUSE. HMS, JDC Adds immunity from civil and criminal liability for individuals who (HSCR734) provide information or assistance in child abuse investigations. Effective 7/1/2060.
