SB 358 Status & Testimony	RELATING TO THE COLLEGE SAVINGS PROGRAM. Establishes a state income tax deduction for eligible contributions made to any college savings program under section 529 of the Internal Revenue Code. Applies to taxable years beginning after 12/31/2020.	HRE, WAM

Allows the chair of the Independent Audit Committee of the University of Hawaii Board of Regents to be selected in a manner consistent with its bylaws and makes other clarifying amendments.	HRE, JDC
