| <u>SB 421</u><br>Status &<br>Testimony                   | RELATING TO VACANCIES.<br>Amends the manner in which a vacancy in the membership of<br>the State Senate is filled and certain time frames relevant<br>thereto.   | JDC |
| <u>SB 528</u><br><u>Status &amp;</u><br><u>Testimony</u> | RELATING TO POLITICAL ADVERTISEMENTS.<br>Requires printed and electronic political advertising to<br>prominently display candidate-approval language on each page.<br>Increases the fine for violations.                                       | JDC |

| <u>SB 635</u><br><u>Status &amp;</u><br><u>Testimony</u> | RELATING TO ELECTIONS.<br>Allows the elections commission to refer a complaint to the<br>attorney general or county prosecutor in addition to any<br>administrative determination and without the requirement that<br>the commission believes the respondent has recklessly,<br>knowingly, or intentionally committed a violation. Disqualifies a<br>person convicted of violating elections criminal prosecution laws<br>from holding elective public office for ten years rather than four.<br>Repeals language stipulating that elections criminal prosecution<br>law does not apply to any persons who has paid or agrees to<br>pay fines related to report filing violations and advertisement<br>violations prior to the commencement of the proceedings. | JDC |

| <u>SB 738</u><br>Status &<br>Testimony                   | RELATING TO SCHEDULE I SUBSTANCES.<br>Removes psilocybin and psilocyn from the list of Schedule I<br>substances. Requires the Department of Health to establish<br>designated treatment centers for the therapeutic administration<br>of psilocybin and psilocyn. Establishes a review panel to review<br>and assess the effects of this measure.   | JDC |
| <u>SB 157</u><br><u>Status &amp;</u><br><u>Testimony</u> | RELATING TO LICENSING.<br>Authorizes the issuance of a civil license to solemnize marriage<br>and allows solemnization by any individual at least eighteen<br>years of age.   | JDC |
| <u>SB 159</u><br>Status &<br>Testimony                   | RELATING TO VOTING.<br>Requires any person who is eligible to vote and applies for a<br>motor vehicle driver's license or identification card to be<br>automatically registered to vote unless the applicant affirmatively<br>declines. Allows an applicant to affirmatively decline to have<br>any of the applicant's information electronically transmitted.<br>Authorizes access to and electronic transmission of databases<br>maintained or operated by the counties or the department of<br>transportation that contains driver's license or identification card<br>information to election officials and the online voter registration<br>system.  | JDC |
| <u>SB 189</u><br><u>Status &amp;</u><br><u>Testimony</u> | RELATING TO DOG BITES.<br>Removes the requirement to prove that the dog has bitten on<br>two separate occasions for dog bite victims to bring legal action<br>against a dog's owner.  | JDC |
| <u>SB 278</u><br>Status &<br>Testimony                   | RELATING TO POLITICAL ADVERTISING.<br>Prohibits the microtargeting of political advertisements on<br>television and social media based on online behavioral data,<br>demographic characteristics, and geographic location below the<br>electoral district level.  | JDC |
